**INTRODUCTION:** Children are considered as the Supreme Asset of any country & a Valuable gift to the Humanity .Children are innocent, vulnerable & dependent and thus they form a Special Category in the Society .The aspect of care & protection assumes more important incase of children who are either neglected or are reported to come in conflict with law .Because of their peculiar mental , emotional and psychological need these children requires special handling irrespective of the fact whether they are in a situation of conflict or in need of care & protection of law owing to a situation of neglect .

The Juvenile Justice (Care & Protection of Children) Act provide a protective umbrella to the children who comes under it's purview .Therefore each associates , care & service providers including the Govt. Functionaries & Member of Statutory Bodies are required to be sensitized to the multiple need of the children and to modify its working to develop a child friendly practice & procedures .

In inviting reference to the objective reflected in the "Integrated Child Protection Scheme" & JJ Act , District Child Protection Unit –Deogarh organized numbers of Workshops related to Training , Sensitization and Advocacy for Stakeholders , Services Providers & Statutory Bodies,

### The objective of the Training & Sensitization

#### Workshop is :

- To enhance the knowledge level & clarity of the Stakeholders & Service Providers on Juvenile Justice Act, Various Laws and Legislation related to Child Rights & Protection .
- To Sensitize the Statutory Bodies & Stakeholders on their Role & Responsibilities towards Child Protection.
- To develop a Service Delivery Structure & a Program delivery Mechanism with the proactive participation of Stakeholders including Civil Societies & Govt. Functionaries which ensure an effective & efficient Juvenile Justice System for the Care & Protection Of Children.

### PROCESS ADOPTED:

Before planning for a Training, Sensitization or an Advocacy Workshop , a Stakeholders Mapping & Analysis has been conducted on random sampling basis . On the basis of the findings, strategy & plan has been made for whom training is needed , who is to be sensitized & with whom advocacy to be done .

On the other hand issues related to Child Protection & Vulnerability were prioritized and accordingly IEC Plan was developed & implemented.

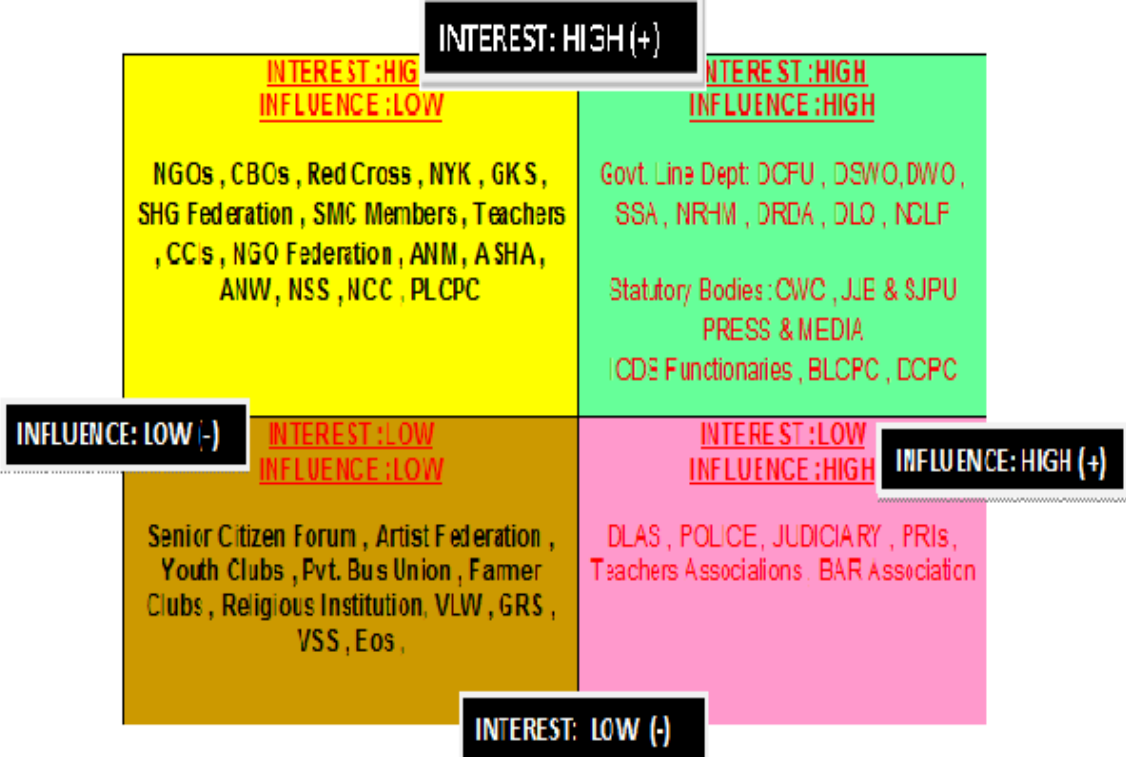
# TRAINING, ADVOCACY & IEC EVENTS: 2016-17 .....at a glance

[C]HIGHLIGHTS of 2016-17 :

***[1] District Level Training Workshop for ASHA & Health Workers on ICPC & Adoption Guideline:***

On dt. 12/04/16 , District Child Protection Unit , Deogarh organized a District Level Training Workshop for ASHA & Health Workers on Integrated Child Protection Scheme [ICPS] and new Adoption Guidelines .

The Block Program Managers of NRHM from Barkote , Teleibani & Reamal Block attend the Workshop as Moderator and provided departmental inputs to the participants to integrate their approach and action plans for effective implementation of Adoption Guideline in the grassroot level.



Ms. Trupti Das from Manas Manjari Shishu Bhawan , SAA , Keonjhar attended the Workshop as the Resource Person . She imparted training to the participants on the Adoption Guideline and invited their support for effective implementation. Mrs. Sujata Mohanadia , POIC[i/c] oriented the participants on various provisions under ICPS including aspects of Non-Institutional Care.

***[2] District Level Training Workshop for ICDS Functionaries on ICPS , New Adoption Guideline and PCM Act***



A District Level Training Workshop on ICPS , New Adoption Guidelines and Prohibition of Child Marriage Act was organized in Little Conference Hall , Deogarh on Dt.25/05/16 for the ICDS functionaries such as selected Anganwadi Workers , Supervisors and CDPOs . Miss Arshu Tudu , District Social Welfare Officer attended the program and inaugurated with her welcome address .

She appealed to all participants to join hands to implement the Act & Schemes with a focused intervention. 3 nos. of ANWs were awarded for their remarkable work in rescue and rehabilitation of Child. IEC materials including leaflets were distributed to all participants. The workshop was coordinated by DCPO, Deogarh. Sri Birendra Meher [Ex-LPO of DCPU, Deogarh] and Ms. Ashrya Das [DISHA Childline] attended the workshop as Resource Person. Around 70 participants attended the workshop and received capacity building inputs.

### ***[3] Sensitization Workshop for BLCPC [Teleibani Block]***

In the Conference Hall of Block Development Office of Teleibani, a Block level Sensitization Workshop on ICPS & Role of BLCPC Members was organized on Dt.19/08/16 with the participation of all BLCPC members including Block Medical Officer, Block Education Officer, CDPO and ABDO.

The Workshop was inaugurated by ABDO of Teleibani. R.Mohapatra, DCPO & Sujata Mohanandia, POIC[i/c] oriented the participants on overview of ICPS and Role of BLCPC Members. The participants received reading materials on ICPS for their reference.



In the last part of the session, the Poster on “Beti Bachao...Beti Padhao” was unfolded by the Block Chairperson.

### ***[4] Sensitization-cum-Review Workshop for DCPC Members on ICPS & Child Friendly Panchayat***

With the suggestion of the Collector & District Magistrate, Deogarh a Sensitization Workshop –cum-Review Meeting was organized in the Conference Hall of DRDA, Deogarh on dt.27/09/16. The Workshop was presided over by the Sri Abhiram Ketketa, PD, DRDA under the Chairmanship of Mrs.Sushma Behera, ZP President-cum-Chairperson, DCPC. Apart from all members of DCPC the other Govt. Functionaries such as Additional District Magistrate, Chief Dist. Medical Officer, DSP-DIB, DSWO, DLO, DSWO also attended the workshop and offered

their technical inputs to implement a convergence model of Child Protection with the integration of all schemes and provisions.

R.Mohapatra , DCPO , through Power Point Presentation presented the Activit Report of DCPU and shared the action plan for the next period and also invited support from all concerned for effective implementation of ICPS.

DCPO took a session on “Child Friendly Panchayats” and shared the indicators to measure the progress.



### ***[5] National Painting Competition in collaboration with OSCCW.***

With the Collaboration of Odisha State Council for Child Welfare [OSCCW] and by the direction of OSCPS , DCPU , Deogarh organized NATIONAL PAINTING COMPETITION-2016 in the Indoor Stadium . Around 220 Children from different educational institutions & CCIs participated in the program . The Children were provided drawing Sheets & Pencils. The event was judged by the Jury Members and the result sheet including the paints was sent to the OSCCW . The program won the appreciation of class , mass & children.





Children of CCIs participated in various events such as Debate , Essay , Painting , Dance & Song. An Art Gallery was exhibited by the children to explore their creativity. Through Art Gallery , Children amplified their voice for their Rights & Entitlements. The winners received mementos & certificates from the Guest.



***[7] Exhibition Stall for Awareness on Child Labour & Adoption in Silver Jubilee Celebration of Maha Laxmi Puja***

During the observation of Silver Jubilee Celebration of Maa Maha Laxmi Puja during Diwali , DCPU exhibited the IEC materials with the installation of Stall on Prohibition of Child Labour Act . Ply Wood Structures with IEC Flex was displayed in the stall which drew the attention of the stakeholders and created a platform for discussion on Operation Mushkan , CHILD LINE Services .

***[8] Exposure Visit of CCI Representatives to Keonjhar for Capacity Building:***

DCPU , Deogarh conducted a special drive for the CCI Representatives for capacity Building through Exposure Visit . A 2 days exposure visit i.e on 11<sup>th</sup> & 12<sup>th</sup> Feb 2017 was organized for the CCI Staffs . 8 nos. of CCI Staffs visited to CCI , Specialized Adoption Agency , CHILDLINE , Special School of Keonjhar District and interacted with the Children and also with the staffs & directors

of the Institutions about the Institutional Care arrangements including reporting & documents ion as per JJ [C & PC] Act.

The Exposure Team also received orientation in the learning sharing sessions conducted in DCPU , CWC & JJB , Keonjhar premises separately. In these session the Best Practices & Successes Stories etc. were shared and discussed. The approach proved to be an excellent medium for exchange of skill , knowledge & experiences between the 2 districts Deogarh & Keonjhar. We extend our hearty thanks to DCPU , Keonjhar for their cooperation & support to make the visit resourceful & educative.



***[9] Observation of World Day against Child Labour in collaboration with DLSA***

In Collaboration with Dist. Legal Service Authority , Deogarh and NGO ROPE , the World Day Against Child Labour was observed in Taiser Gram Panchayat of Teleibani Block with the participation of SHG Groups , Civil Society Members , Children & Youth Clubs . The program was graced by Hon’ble District & Session Judge Sri Bikram Keshari Pattanayak as Chief Guest , Dist. Labour Officer & DCPO as Guest of Honour . The program was hosted by Miss S.Subhadarsini , Secretary , DLSA , Deogarh . In the occasion , the one Child Friendly Dhaba Owner i.e Sri Tiwariji of Tiwari Dhaba was awarded for running his dhaba without engagement of Child Labour.



***[10] District Level Advocacy Workshop on Child Friendly Panchayat and Effective Implementation of JJ [C&PC] Act***

Under the Chairmanship of Sri Purna Chandra Pathy , Collector & District Magistrate , Deogarh a Concept Clarity & Vision Building Workshop on “SHISHU MITRA PANCHAYAT “ was organized for the Chairpersons [Sarapanchs] of Panchayat Level Child Protection Committee [PLCPC] . Orientation was provided to the participants on JJ [C&PC] Act and ICPS by Sri Abul Kalam Azad , Director , DISHA Childline , Rourkela. For concept clarity & vision building of participants on “Child Friendly Panchayats” in the context of ICPS was oriented by R.Mohapatra , DCPO . It was observed that many of the Sarapanchs were highly enthusiastic and expressed that interest to make their panchayat as “Shishu Mitra Panchayat” and try to prohibit Child Marriage , Child Labour & Child Abuse Cases in their panchayats and also ensure 100% enrollment of Children in School , 100% immunization of Children , regular meeting of PLCPC to address the issues related to Child Protection.

In this occasion, the Collector Mr.Pathy enfolded the Poster on “Shishu Mitra Panchayat”.



## ***[11] Observation of National Girl Child Day-2017***

***[12] Open Air Consultation Meet & Campaign on "Save Girl Child" through T20 Cricket Match between Advocates & Administrative Officers***

On 26<sup>th</sup> January 2017, a T20 Cricket Match between ADMISISTRATION-XI v/s BAR ASSOCIATION-XI was played in the IG Stadium to campaign for "Save Girl Child – Save Deogarh". The match was won by the BAR ASSOCIATION with 50 runs . In this occasion an Outdoor Consultation Meeting was organized under open sky in the stadium on Effective Implementation of Juvenile Justice [C&PC] Act and POCSO Act . Apart from Collector & SP, around 70 Advocates & Officers participated in the meet & extend their views on Effective Implementation of the Acts in the District for the protection of Children .The Advocates came on to the ground with Ply Card on "Save Girl Child" in their hands & jersey in their body with slogan such as "Save Girls ...Save Deogarh".
