Sealed tenders are invited from travel agencies/transporter/individuals/private organizations situated within Deogarh district for hiring of two nos. of multi utility vehicles (SCORPIO, BOLERO, XYLO etc) with/without AC to be engaged for DPMU, NHM , Deogarh at district level on monthly hiring basis. The quotationers shall have to submit two envelopes, one for technical bid & second for financial bid through speed post/register post/courier only on or before 20.06:2018 to the office of CDM & PHO, DHH, Deogarh .The quotation will open on 21.06.2018 at 11.00 AM .The tender paper along with terms and conditions will be available in the website www.deogarh.nic.in. The authority reserves right to accept or reject any or all the tender without assigning any reason thereof. The envelope containing the tender must be clearly super scribed as “ Tender for Hiring of vehicle for DPMU, NHM, Deogarh”

TERMS & CONDITIONS FOR HIRING OF VEHICLE

1. The contract of engagement must be entered into with the travel agency/transporter/individuals/private organization & the CDM & PHO, Deogarh.
2. EMD of Rs 5,000/- per each vehicle (Refundable) in shape of DD in favor of ZSS/ Non- NRHM Funds Account, Deogarh Payable at Deogarh should be submitted along with the bid.
3. All the vehicles must not be more than 2 years old at the time of tender opening.
4. The vehicle should have valid – commercial registration, Commercial permit, Insurance coverage, Fitness certificate, Pollution certificate and Road tax clearance.
5. The vehicle must be in a good condition and should be a multi utility vehicle.
6. The vehicle to be engaged should not belong to any employee of NHM, any health department employee.
7. The contract period should not exceed 12 months at a time.
8. The travel agencies/transporter/individuals/private organizations must have its office at the district head quarter, Deogarh.
9. The driver will report to District Programme Manager, NHM, Deogarh at 8 AM in the morning and will be available till 8 PM in the evening to drive the vehicle.
10. In case the driver is called at night no extra charge will be paid and there will be no night halt charges for using the vehicle at night.
11. Maintenance including cost of driver and all the taxes of the vehicle will be borne by the owner.
12. Bidders or his/her authorized representative must be present with their vehicle at the time of tender opening for verification.
13. The vehicle will remain with concerned office on all working days & on holidays as desired by the concerned authority.
14. Owner must make alternative arrangements if regular driver is absent or the vehicle become off road.
15. The vehicle should not be spared for private use of any officials of concerned office.
16. The record of vehicle usage & log book will be maintained by the second party & countersign by the concerned member of DPMU office Deogarh on a daily basis.
17. No advance payment will be made by the authority to the party. The billing will be done on a monthly basis and it should be submitted by the party within the first week of the following month.
18. The payment will be made only on production of photocopy of log book which have been duly signed by the authority or any authorized officer. It will be the responsibility of the driver to get approved log book and duty slips for each occasion of journey signed by the authority or any authorized officer on day to day basis.
19. If during the course of engagement of the vehicle any accidents etc, occurred either to vehicle or to the third party, authority will not be responsible and any liability arising out such accident will be the responsibility of the party only.



20. In case of the service executed is not to the satisfaction then the authority shall issue show cause notice to the party to comply the conditions as mentioned in the agreement. In case of non-compliance, the authority may terminate the agreement and also can forfeit any amount due to party.
21. Any dispute arising out of this contract will be subjected to jurisdiction of the court in the Deogarh district only.
22. Before engagement the valid driving license of driver with police station clearance certificate should be submitted for office record purpose
23. The vehicle owner and driver must strictly adhere to the latest motor vehicle act and rules , failure of which contract will be cancelled.
24. The application in the prescribed format should reach the "Chief District Medical & Public Health Officer, Deogarh, At/Po./Dist- Deogarh pin-768108" through Speed post/Registered Post/ Courier only.
25. The envelope must be super scribed with "Tender for Hiring of vehicle for DPMU, NHM, Deogarh should reach the above address within 20.06.2018. The authority will not hold responsible for any postal delay or missing. The incomplete application in any form is liable for rejection.
