INVITATION FOR BIDS (IFB) BID IDENTIFICATION No: EEMID DGR- 01 of 2018-19

The Executive Engineer, M.I Division, Deogarh on behalf of the Hon'ble Governor of Odisha invites on-line percentage (%) rate bids through e-procurement for the following Civil Construction work as detailed in Annexure from the eligible class of contractors registered with the State Government of Odisha and Contractors of equivalent grade/ Class registered with Central Govt./ MES/ Railways/CPWD on production of definite proof from the appropriate authority to be eventually drawn up in OPWD form of P1 contract. The bidders required to submit their bids for the following work(s) on-line in the website (www.tendersorissa.gov.in). The bid documents will be available in above website on **dt.04-08-2018** from **10.00 Hrs** to **dt.18-08-2018** up to **17.00 Hrs** for "On-line bidding". The bidders must possess compatible digital signature certificates (DSC) of Class-II or Class-III to participate in the on-line bid.

TERMS AND CONDITIONS

1. Bids must be accompanied with on line receipt of tender paper cost and EMD through e-procurement, Affidavit along with all tender documents specified for the work in the shape as detailed in the DTCN without which the tender is liable for rejection. No hard copy for payment of Tender Paper cost and EMD will be accepted and bids will be cancelled.
2. In case the cost of tender paper increase due to GST as per applicable of Govt rule or any Govt. notification, the tenderer have to furnish the excess cost.
3. Other details can be seen from the Bidding documents which is available in Website www.tendersorissa.gov.in
4. (a) Engineer contractors who want to avail EMD exemption have to submit one affidavit with tender declaring therein to the effect that they have not yet availed 3 (three) nos of EMD exemption during the financial year 2018-19 and to show the original Registration Certificate to the tender opening authority for confirmation at the time of agreement.
 (b) Engineer contractor registration under concessional scheme are not subdivided as SC/ ST and other, Hence facility availed by the SC/ ST contractor will not be allowed to an Engineer contractor belonging to SC/ ST categories.
 (c) The security deposit (earnest money, initial security & performance security) at half the usual rate may be deposited realized by/ from the SC or ST contractor coming under the categories upto "B" class only. The SC/ ST contractor who are willing to avail 10% price preference should produce an affidavit in writing.
5. Additional performance security will be submitted by the lowest successful bidder when the bid amount is less than the estimated cost put to tender within seven days otherwise his/her EMD will be forfeited. In such an event, the bidder who have quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional performance Security in shape of **Term Deposit Receipt / NSC / KVP duly pledged** in favour of the Divisional Officer as per letter no 13286 dt.07-09-2017 of works Deptt.
6. The Bid documents should be up-loaded by the Bidders on-line in www.tendersorissa.gov.in accompanying the scanned copies of valid Registration certificate, GST certificate, PAN card, Labour license/ undertaking, on line receipt of EMD cost of tender paper, no relation certificate & affidavit in proper format as per Annexure- 'A' & 'B' provided in the DTCN about the authenticity of the tender documents failing which the Bids will be rejected. Labour licence has to be furnished by the successful bidder within 15 days after receipt of work order and drawal of agreement.

7. If any bidder participates in more than one bid of total cost amounting to Rs.100,00,000.00 (Rupees hundred lakh) or more their eligibility will be subject to their bid capacity, in which case the bidder have to submit their work in hand during the current year, Annual turnover for last 3(three) years duly certified by a Chartered Accountant & work experience in similar nature of work.
8. If the rate quoted by the bidder is less than 15% of the tendered amount, then such a bid shall be rejected out-rightly and the tender shall be finalized basing on the merits of rest of the bids. But if more than one bid is quoted at 14.99% (Decimals upto two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where bidders/ their authorized representatives, the concerned Executive Engineer and DAO will remain present as per Memorandum 12366 dated 08.11.2013 of Works Department,
9. The tender will be opened on **dt. 20-08-2018 at 11.00** Hrs in the office of the Executive Engineer, M.I.Division, Deogarh. In the event of the quoted rates of the bidders comes equal, in such case a date for lottery to find the winning bidder will be notified later.
10. After opening of the bid, the originals of scanned documents of the successful lowest bidder will be verified by the tender accepting authority within 07 (seven) working days of the opening of the tender.
11. Bid for the work shall remain open for acceptance for a period of 90 (Ninety) days from the last date of receipt of Bids. If any Bidder/ Tenderer withdraw his Bid/ tender before the above said period or make any modifications in terms & conditions of the Bid, the said bid shall be rejected and the earnest money shall stand forfeited.
12. No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department in State Government is allowed to work as contractor for a period of two years after his retirement from Government Service without Government permission.
13. The bidder must go through the Bid Documents meticulously before up-loading the tender to the web-site.
14. All taxes, fees, royalties payable under the local rules including GST, Cess, income taxes & surcharges as applicable etc shall be borne by the contractor. Labour cess @ 1% will be deducted from the work bill from the contractor/supplier as per resolution No. 12563 dated 15.12.2008 of the Labour & Employment Department, Govt. of Odisha. It is implied that, the quoted rates are inclusive of such elements.
15. The on-line bidding process shall be Governed by e-procurement guide line of Govt. of Odisha vide Works Deptt. No. FAR- 3/ 08-1027/ W dt. 24.01.2009 & relevant clauses of the OPWD codes in force.
16. Guidelines laid down in office memorandum no.7885 dated 23.07.2013 and 12366 dated 08.11.2013 of Govt. of Odisha, Works Department will be followed scrupulously for online bidding system.
17. Any corrigendum/ Addendum will be displayed in the website www.tendersorissa.gov.in.
18. The online receipt of Tender paper cost and EMD through e-procurement portal will be mandatory vide circular No-17254 dt.05.12.2017 and No.17276 dt. 06.12.2017 of works Deptt. Govt. of Odisha.
