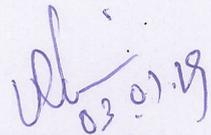
QUOTATION CALL NOTICE

Sealed Quotation are invited in Prescribed Tender Paper from the registered Printers / Firms having valid GST registration/PAN clearance for printing & supply of question-cum-blank answer sheets for 2018-19 from class-I to class-VIII of all Govt. and Govt. Aided School of Deogarh District. Quotation should be submitted with the following terms & conditions specified here under & the envelope containing the quotation should be duly superscribed as "QUOTATION FOR PRINTING AND SUPPLY OF QUESTION –CUM- BLANK ANSWERSHEET" for 2018-19.

TERM AND CONDITION:

1. **Cost of Tender Paper:** The cost of tender paper is Rs.500/-(Rupees Five Hundred) only. Entire tender paper can only be downloaded from website www.opepa.odisha.govt.in and www.deogarh.nic.in .The non refundable cost of tender must be in shape of Bank draft only drawn in favour of District Project Coordinator, RTE-SSA, Deogarh payable at Deogarh, must be attached with tender paper. No exemption in the cost of tender paper will be allowed to the firm even if they are registered under NSIC/OSIC/GM DIC etc.
2. **Paper Quality :** 60 GSM (Cream Wove)
3. **Size of the question Paper :** 1/4th Demy
4. **Quality of Printing:** Letter size as per the sample with both sides printing (To be obtained from District Project Office, RTE-SSA, Deogarh)
5. **Sample Paper:** Only prescribed paper is allowed in tenders/quotations, other paper will not allow for the purpose.
6. **Rate of Printing:** Rate of Printing should included paper cost, Printing, Plate Making, Stitching and Packing.The rate must be quoted separately for single side and double side printing of 1000 sheets(One sheet means two pages) inclusive all the taxes
7. Printing must be offset process using eco friendly ink (I.S.O.I.S.I) standard.
8. Bidder must attach the sample paper as prescribed in the tender call notice.The attached sample paper is to be duly marked for printing of question-cum-blank answer sheets for 2018-19
9. Conditional tender shall not be considered.
10. **Place, Date and Time of receiving Tender:** District Project Office, SSA, Deogarh on or before Dt-21/ 01/2019 by 5 PM (by Regd. or Speed Post)
11. **Opening of Quotation :**
On 22/01/2019 at District Project Office, RTE,SSA, Deogarh at 11 A.M in the presence of bidder or their authorized representative who may present.

12. **EMD:** The indenting bidder will have to deposit Rs.6000/- Six Thousand) only in shape of Bank Draft in favour of **District Project coordinator, SSA, Deogarh** (amount refundable) payable at , Deogarh
13. **Deposit of security Money:-**The successful bidder shall be required to submit security deposit of Rs. 15.000/- (Rupees Fifteen Thousand) only i.e 5% of contract price approximately) in shape of Bank Draft of any Nationalized Bank in favour of District Project Coordinator, SSA, Deogarh (refundable) payable at Deogarh .
14. After use, if any doubt will arise on quality of GSM ,printed sample may be sent to concerned mill for confirmation of its quality if required by the certifying authority.
15. Question –cum-answer sheet shall be packed and supplied as per indent in sealed packed i.e. subject wise, school wise, cluster wise and block wise in gunny bags. The details shall be furnished at the time of issue of work order. The bidder will be responsible for proper counting of exact number of Question-cum-answer sheets
16. **Supply of Question-cum-blank answer sheets:** Delivery should be made at Block HQs of three Blocks, within ten days from the issue of work order, failing which the security deposit will be forfeited.
17. Payment will be made to the party only after obtaining clearance &no objection certificate from the blocks to whom the question papers will be delivered by the firms and on the basis of testing the quality of papers as directed by OPEPA, Bhubaneswar.
18. **Transportation Cost:** Cost of Transportation from printing press to block head quarter will be charged as per local government rate.
19. In case of any discrepancies the EMD and security deposit of the bidder will be forfeited.
20. In case of any dispute in the process or contract would be subject to the court of jurisdiction of District Head quarter, Deogarh only.
21. The selected firm/press has to make an agreement with the DPC,RTE-SSA,Deogarh soon after the selection of the bidder to print and supply the printed and packed Question-cum-Answersheet as per the terms and conditions.
22. The bidder have to submit their technical bid and financial bid as per the format enclosed at annexure "A"and "B"
23. The Collector-cum-chairman reserves the right to modify or cancel any quotation without assigning any reason thereof.

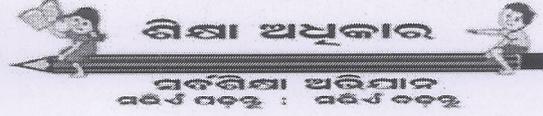

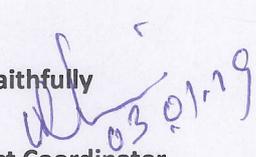
