Consequent upon non joining of a Candidate vide Sl. No.10 of this office order No.25, dt.17.05.2019 to fill up the existing vacancies made in pursuance to Advertisement No.2 of 2018, dt.20.08.2018 in the cadre of Jr. Clerk -cum- Copyist the following candidates of the separate merit list prepared by the District Recruitment Committee, Deogarh for the S.C. category is newly appointed as Jr. Clerk-cum-Copyist subject to the result of W.P.(C) No.1273 of 2014, for smooth management of office work in exigency of public service and for inquest of administration.
