

- b) The rate may be quoted item-wise or in totaling to the each set.
- c) The rate quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- d) The bidder can enhance the wattage of particular of Light & Sound System in the quotation for necessary requirement of composition for smooth operating of system, but rate should be quoted according to the wattage of particulars given.
- e) Successful L-1 bidder will be selected among the equal lowest bidder, basing on the inclusion of additional equipment or having advance technology of equipment or exceeding the wattage.
- f) The Supplier/Vendor should be provided **Expert Operators** for operating of Light & Sound.
- g) The Test check should be done by the evening of **9<sup>th</sup> February, 2020** positively.
