## TENDER CALL NOTICE

Sealed quotations/tenders are hereby invited from the intending reputed Firms/Agencies in the prescribed format for Supply of **“Pictorial Tiles printed with PMAY(G)- BPGY Logo” (15X15 inch with 8 mm thickness)** and delivery at all 03 Blocks of Deogarh District as per Design Types & Specifications .

The sealed quotations/tenders completed in all respect should reach the undersigned on or before 15/12/2020 by **1.30 P.M through Registered Post/Speed Post** only addressed to the **Project Director, DRDA, Deogarh, Purunagarh -768119** and will be opened on the same day at **4.30 PM** in the office chamber of Project Director, DRDA, Deogarh in the presence of the bidders or their authorized representatives. If this day is declared later as Government holiday, the quotations/tenders will be received and opened on the next working day as per the scheduled time.

The quotation/tenders received beyond the stipulated date and time and incomplete quotation/tenders in any respect shall not be taken into consideration and liable for rejection. The DRDA shall not be responsible for any postal delay.

The sealed quotation/ tenders shall be submitted in a sealed envelope/ cover & super scribed with **“QUOTATION/TENDERS FOR SUPPLY OF PICTORIAL TILE PAINTED WITH PMAY (G) - BPGY LOGO”**.

The request for proposal / application form of quotation/tender containing General Bid information with Terms & conditions, detail Specifications of PMAY (G)-BPGY logo can be viewed/ downloaded from the District website i.e [www.deogarh.nic.in](http://www.deogarh.nic.in) . Non refundable Demand Draft of Rs 5000/- ( Rupees five thousand) only in favour of Project Director, DRDA, Deogarh payable at Deogarh shall be deposited along with the Bid Documents towards cost of Tender Paper.

### **Terms & Conditions:**

1. The bidder must be a reputed Firm/Agency & must have similar work experience.
2. The bidder can submit only one bid. Multiple bids submitted by any bidder shall result in rejection of all his/her bids.
3. The bidder must have been registered under Goods & Services Tax (GST) Act and must have a valid GSTIN number. The bidder must PAN/TAN number.
4. The bidder must have minimum turnover worth Rs 10.00 Lakh during the last 3(three) years. Copy of the ITR of the firms for corresponding financial year/ copy of the audited Financial statements of the last three financial year duly attested by the Chartered Accountant should be attached with the applications.
5. The quotation shall remain valid for a period not less than One Year after the date specified for submission.
6. The bidder/ representative of the bidder must submit a sample PMAY(G)- BPGY logo tile as per the specification during the opening of the tender document.
7. Intending firms/ suppliers may submit the quoted price in the prescribed Performa enclosed as annexure-A along with copy of GST registration certificate, PAN Card & all other documents as specified in the Tender advertisement.
8. The rate quoted should be inclusive of all taxes and other dues like transportation cost up to the delivery point i.e all 03 Blocks head quarters of Deogarh District.

9. The selected bidder has to supply the said material within fifteen days from the date of issuance of work order.
10. The purchaser will examine, evaluate, and compare the quotations received from the respective bidders and select the L1 bidder taking in to consideration the lowest price quoted for all items taken together.
11. Any effort by Firms/Agencies to influence the purchaser in its decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.
12. The bidder whose bid is accepted will be notified of the award of contract by the purchaser prior to expiration of the quotation validity period . The terms of the accepted offer shall be incorporated in the purchase order.
13. The 2<sup>nd</sup> Lowest Firms/Agencies will be offered for supply of said material at the approved quoted price of the L1 bidder if the 1<sup>st</sup> Lowest differ fails to supply and this will be followed by forfeiting of EMD of the 1<sup>st</sup> lowest bidder.
14. Payment will be made after receipt of the Tile painted in good condition as per the Specification, Design Types & Specifications given by this office and delivery at all 03 Blocks of Deogarh District. . The damage during transit will be borne by the bidder. A random quality and quantity check will be conducted at the time of each delivery. The Bidder will obtain completion certificate from concerned Block Development Officers after successful delivery of the pictorial tiles and submit them along with bill for payment.
15. A sum of Rs.20,000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Project Director, DRDA, Deogarh payable at SBI, Main Branch, Deogah and submitted along with the tender as Security Deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
16. A Non-refundable Account Payee Bank Draft amounting to Rs.5,000/ in favour of the Project Director, DRDA, Deogarh payable at SBI, Main Branch, Deogarh shall be deposited alongwith tender paper towards cost of tender paper .
17. The authority reserves all rights to accept or reject any or all the quotation/tenders without assigning any reason thereof.

- EMD amounting to Rs 20,000/- ( Rupees twenty thousand) only for supply of PMAY(G)-BPGY logo in the shape of Demand Draft issued by any scheduled commercial bank in favour of in favour of Project Director, DRDA, Deogarh, payable at Deogarh.






