**Technical & Financial Specification for the work :**

The Agency / Firm must have valid GST Registration Number with previous experience with same type of work . The Quotationers should submit the following document along with the Quotation Submission form (at Annexure-A): (1) Copy of GST registration Certificate , (2) Updated GST Return Copy , (3) Photocopy of PAN Card , (4) Last Year IT Return Copy , (5) Copy of Work Order (if any) executed in similar type of work . The undersigned will not make any advance payment to the agency . The agency will have to carry out the entire job on its own . The agency must complete the assignment within 15 days of issuance of work order .The payment will be made through PFMS only after satisfactory completion of the work with submission of bills in that regard .

**Item Specification:**

13x10 ft Iron Framed Hoarding Structure on 4”x2”x6” mm U channel , 3 ft digged in the ground with concrete dhalai , height of frame 8ft from ground level , 2” angle framed in fabrication . Frame should be in iron angle. Best Quality Flex with digital multi colored printing is to be pasted on the frame . Flex should be fixed through iron pipes and GI wires. The hoarding is inclusive of all tax , material cost , transportation , erection , mounting and AMC upto 1 year .

The Quotations complete in all respect should reach/drop before the Office of District Child Protection Officer (DCPO) , At-Municipality Sahi (Near Punjab National Bank) , Deogarh on or before **dt-24<sup>th</sup> Feb 2021 by 1 PM through Register Post / Speed Post / In Person** .
