The quotation must be delivered to ITDA, Tileibani situated at Deogarh by Regd. Post/ Speed Post or in Person during Office hours from 10.00 A.M to 5.00 P.M. The last date of receipt of sealed quotations is dt.21.06.2021 up to 5.00 P.M, which will be opened on dt. 22.06.2021 at 11.00 A.M. in presence of the Quotationers or their Representatives.

1	Fabricating and supplying of poultry shed of size 5'×5'×3'.6" made of MS angle of size 25mm × 25mm × 5 mm , G.I weld mesh Jalli 4 side of minimum 2mm and 1" × 1" size & bottom of minimum 2mm and 0.5" × 0.5" size, galvanized profile shut for roof with 6" projection in all sides hinged door 1'6" × 1'6" opening with lock, 8" long 4 nos. of legs. The MS angle should be painted with superior enamel paint of approved colour over a coat of red oxide primer and transparent shut. Tin plate of size 10" × 6" fixed near the entrance. The poultry shed cage should be properly welded except the roof which is to be fixed with nuts and bolts finished in all respects with total weight of minimum 80 kg as per the specification and direction of user agency. The cost of the poultry shed should be inclusive of all taxes and transportation to the desired location under ITDA, Tileibani area.
