Terms & Conditions:

1. The engagement is purely temporary and terminable at any time without notice and assigning any reason thereof.
2. She/ He shall submit the written Undertaking in the Model Form prior to his joining in the respective post as per contractual engagement.
3. She/He shall continue as Initial Appointee for a period of six years, which shall be reckoned from the date of their appointment.
4. On the date of satisfactory completion of six years of Initial Appointee service after joining, he shall be considered for regular appointment. On regular appointment he shall be entitled to draw the time scale of Pay plus D.A. and other allowances as admissible from time to time by the Govt.
5. Subject to satisfactory performance, the remuneration shall be enhanced as per slabs prescribed under the Annexure appended to the Odisha Group-B posts (Contractual

Appointment) Amendment Rules, 2021 vide Notification No.28626/Gen., dt.27.10.2021 of GA & PG Department, Odisha Bhubaneswar on completion of each year of service.

6. She/ He shall not be entitled to DA, HRA and other allowances except RCM during the period of Initial Appointment.
7. She/ He shall abide by the Odisha Civil Servants Conduct Rules, 1959 and O.C.S. (C.C.&A) Rules, 1962.
8. She/ He should submit the following document at the time of his/her joining in the post failing which the joining report shall not be accepted.
  - a) Medical fitness certificate signed by the Govt. Medical Practitioner not below the rank of Asst. Surgeon.
  - b) Two character certificate from two Gazetted Officers.
  - c) Two passport size photographs (self attested).
  - d) Copies of Certificates in support of her/his qualification and date of birth/ resident/ caste (self attested).
  - e) Martial declaration, if married, having not more than one spouse living.
  - f) Oath of allegiance to the Constitution of India.
  - g) RTPCR Report from Competent Authority.
9. She/ He should report for duty before the concerned authority by dt.22.12.2021 failing which the appointment order shall be automatically cancelled.
