NOTIFICATION

In exercise of the powers conferred by Sub -Sections (3) and (3-A) of Section 12 of the Odisha Municipal Act. 1950 (Odisha Act 23 of 1950) read with Sub-Rule (1) of Rule 2A of the Orissa Municipal (Delimitation of Wards, Reservation of Seats and conduct of Election) Rules, 1994 Notice is hereby given that the DEOGARH MUNICIPAL COUNCIL in the district of DEOGARH shall be divided into 11 (Eleven) Wards as specified in Column (2) of the Statement-I below with the description and boundaries of the said Wards against each in Column (3) and (4) respectively thereof for the purpose of ensuing Election of Councilors to the same and the Wards as specified in Column (2) of the statement-II below in which the Seats reserved under Section 11 of the said Act shall be set assigned each in Column (3) thereof.
