TERMS AND CONDITIONS:

For Private Medical Store:

1. The Drug store should have valid license under Drug & Cosmetic act of Govt. Schedule.
2. Medicine stores near the Hospital within 200 Mtr. radius will be considered and if no medicine store available within 200 Mtr. radius the beyond that medicine store will be considered.
3. The medicine store giving maximum Discount on MRP (must not less than 10%) will be selected for L1.
4. The medicine store must have stock of drugs not less than 75% of the commonly prescribed medicines of that Hospital.
5. If any medicine to be procured is not available in the medicine store it is the responsibility of the Store to arrange it and supply it quickly. i.e. within 6hrs.
6. The medicine store should provide the lease agreement more than one year of validity from the last date of tender advertisement.
7. If any Janaushadhi Kendra (within the areas per the above distance) applied will be given preference with minimal discount or no discount.
8. The bidder who have applied in response to the earlier need not apply afresh.

Other terms and Conditions:

13. The Services should be available round the clock for DHH, Deogarh (i.e.24x7)
14. The tender shall be inclusive of all taxes. VAT clearance certificate should be submitted in form VAT-612 (TAX related documents).
15. The successful tender should supply/ provide the items as per the instruction of this office positively or else the supply order shall be automatically cancelled.


