

TERM AND CONDITIONS

1. One number of old condemned Mohindra & Mahindra jeep bearing Regd. No.OR-05-A-2951 purchased during the year 1992 will be sold on "As is where is basis" sealed tender. Upset price of the vehicle is fixed at Rs.15000/- (Rupees fifteen thousand) only.
2. The intending tenders may inspect the vehicle at District Fisheries Officer, Deogarh from 11A.M. TO 4 PM in any working day up to 01.08.2022.
3. Each tender should be accompanied by earnest money of Rs.1000/- (Rupees one thousand) only in shape of Bank draft in favour of District Fisheries Officer, Deogarh to be drawn at State bank of India, Deogarh.
4. The successful tenderer shall be deposit 25% of the offered amount immediately on the spot after the announcement and rest 75% amount within 07days from the date of acceptance of the tender before the District Fisheries Officer, Deogarh.
5. The vehicle shall not be delivered to the tender until full payment is made.
6. The tenderer shall remove the vehicle from the place as indicated in the item-2 above where the vehicle is parked within 07days from the deposit of the full tendered value. The custody and safe guard of the vehicle thereafter shall be responsibility of the tenderer. No request for extension time on any account shall be entertained.
7. On failure to remove the vehicle within the schedule time, ground rent at the rate of 1% of the tender value shall be charged for each day or part of the daya till removal of the vehicle from site.
8. Where the ground rent so charged, exceed the sale price deposited, the bidder/tenderer shall be adjusted towards the ground rent and the vehicle shall be property of Government free from encumbrances and disposed of the fresh auction or tender as the case may be.
9. Unsuccessful tenderer may be refunded with the bank draft (earnest money) on the spot, if desired.
10. G.S.T. as applicable shall be charged extra over and above the tender money which is o be the tenderer at the time of full payment.
11. The authority reserves the right to reject any or all tenders without assigning any reasons thereof.
