

Quotation /Tender Call Notice

Sealed quotation /tender are invited from interested reputed Travel Agencies/ Tour Operators or private individuals for providing 01 nos of Non AC/AC Diesel driven vehicles having sitting capacity not more than five including driver ,which shall conform to the term and conditions (Annexure –II) for official use in Divisional Labour Office Deogarh on monthly rent basis :-

- 1- The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2- The Driver of the vehicle must have a valid Driving License for Driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3- The Driver Should be well behaved, gentle and obedient in nature.
- 4- A sum of Rs-5000/-shall be deposited by the intending bidders in shape of Account payee Bank Draft drawn in favour of the District Labour Officer Deogarh submitted along with the tender as security deposit .After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5- The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants)
- 6- The vehicle must achieve a fuel efficiency of 17Kms per liter.
- 7- The details of the make and year of manufacture of the vehicle registration no, mileage (Kms covered per liter)and name of the Driver with Driving License No and period of validity should be specifically provided in the general bid information to be furnished with the Quotation /Tender (Annexure-II)
- 8- The Quotation completed in all respect should reach the undersigned on or before by 10.am and Shall be opened on by 11. am in presence of the bidders of their authorized representatives.
- 9- The application form of Quotation /tender containing General Bid information & Term and condition for Hiring of Vehicle etc. will be available with o/o the District Labour Office Deogarh on amount of Rs-100/-From 06.08.2022 to 16.08.2022 or can be downloaded from Odisha Govt.Website www.Odisha.gov.infrom Dt:- to Dt: - In case the application form is downloaded from Govt.Website the application shall furnish a Demand Draft for an Amount Rs-100/- (Rupees One Hundred) Only towards the cost of application along with the application.
