

TERMS AND CONDITIONS FOR SUPPLY AND INSTALLATION OF SOLAR STREET LIGHTING SYSTEMS TO DIFFERENT VILLAGE UNDER BARKOTE BLOCK

1. Eligibility Criteria

1. The bidder should either be a manufacturer/ dealer/ supplier of Solar PV Modules (using mono/poly silicon crystalline Cells) or a Solar PV System Integrator and should have experience of having executed contracts of Supply, Installation and Commissioning of Solar PV power plant.
2. Preferably have office & field service center within 50 km from the place of installation to provide good after sale services including necessary repair and maintenance.
3. The name, address and mobile number of the contact person to be provided.
4. Bidder should provide GST no.
5. Bidder should provide PAN no.
6. Bidder should submit manufacturer authorization certificates

2. Instructions to Bidders

Bidders must submit their bids for Solar Lighting Systems.

Bids must be submitted in English language only.

In-complete bids shall not be accepted.

Prices quoted must be firm and fixed. No price variation / escalation shall be allowed.

The bidders must sign and stamp at the bottom of each page of the bid documents at the time of submission in token of unconditional acceptance of the departmental terms and conditions, technical specifications etc.

Last IT Return Statement / Valid GST / Copy of PAN card / Registration Certificate duly attested must be submitted along with the bid.

Deviations in Terms and Conditions, Specification of material, Inspection clause etc. will not be accepted under normal conditions. However under exceptional situation the same may be considered at the discretion of Block Development Officer, Barkote.

Earnest money as specified in bid may be deposited in shape of Demand Draft drawn in favour of the Block Development Officer, Barkote.

Bids without E.M.D and Cost of Tender Papers shall not be accepted.

Bids received late due to postal delay or otherwise **will not be considered.**

The quantity of materials intended to be purchased as mentioned in this documents is subject to alteration without any notice.

The bidders are required to furnish their offers in the price bid both in

words & figures. In case of corrections if any, the original text/numerical must be clearly crossed out and re-written legibly above, below or on the side of the crossed out characters as per availability of space and the authorized person must put his dated initial under such corrections. In case of any conflict between figures and words, the later shall prevail.

Since timely execution of works is of paramount importance, requests for extension of time shall not be ordinarily entertained.

Canvassing in any manner shall not be entertained and will be viewed seriously leading to rejection of the bid.

All essential supplementing documents should be signed and stamped and in case of need for verification, originals should be produced

The out of state bidders must be having / willing to open a local office at Deogarh before commencement of work for close coordination with Block Development Officer, Barkote and also cluster level service centres at suitable places as will be indicated by Block Development Officer, Barkote during installation of the systems.

The bidders must remain prepared for submitting information such as identity proof of beneficiaries, photographs, GPS locations of the villages etc. along with installation reports

Power of attorney to sign the agreement on behalf of bidders & partnership deed articles, if any, should be enclosed along with original bid documents.

Notice inviting tender, bid documents, prescribed Technical bid, price bid, terms & conditions will form the part of the tender.

Bids will be accepted & will be opened as per information mentioned in the notice- inviting tender. No receipt against submission of bid shall be issued by Block Development Officer, Barkote.

The last date of receipt of the bid is **20.08.2022** up to 12.00PM.

Sealed tenders shall only be received by the Block Development Officer, Barkote through Registered Post/ Speed Post/ Courier/ by person. If due to any reason the due date is declared as a holiday the bid will be opened on next working day at the same time.

The technical bid shall be opened on **20.08.2022** at **12.00 PM** in the office chamber of Block Development Officer, Barkote in presence of such bidders or their authorized representatives, who may like to be present at the time of opening.

The bid document should be submitted in two parts as detailed below:

Bids should be submitted through Registered Post / Speed Post/ Courier/ by hand in two separate sealed envelope as mentioned below & addressed to the Block Development Officer, Barkote, At/Po-Barkote, Dist: Deogarh, inside a sealed envelope superscribed " Bid for Solar PV Lighting System against Bid Call

Notice No. 1300 dt. 18.05.2022. First sealed envelope should contain Demand draft towards cost of bid document and cost of tender papers, Technical Bid as per Annexure – A, Earnest Money, Technical Specification, valid GST, Income Tax return, PAN card Commercial terms & conditions, other bid documents duly signed & sealed. It should be super-scribed with Part-I Technical Bid ". All the papers of bid documents except the price bid duly signed should be submitted in the first envelope. Required earnest money deposited in the form of Demand Draft in favour of Block Development Officer, Barkote payable at Block Development Officer, Barkote should be attached.

Second sealed envelope: (part-II) should contain Price bid as per Annexure –B, in a separate sealed envelope. It should be super-scribed with "PART- II PRICE BID". Any condition in regard to financial aspects, payments, terms of rebate etc beyond the prescribed financial terms of Block Development Officer, Barkote will make the bid invalid. Therefore it is in the interest of the bidders not to write anything extra in the Price Bid in Annexure-B except price.

The authority reserves the right to cancel or postpone the bids without assigning any reason thereof.

During the warranty period, Officials of District Administration / Block Administration/ PRI members / Users reserves the right to cross check the performance of the system with the minimum performance levels as per specifications.

4 Procedure for opening the bids

The procedure of opening of the bid shall be as under First envelope "TECHNICAL BID" shall be opened at the time & date mentioned in the bid notice by Block Development Officer, Barkote in the presence of bidders / or their representative, who choose to be present.

Second envelope (part-II) containing Price bid shall be opened after evaluation of technical suitability of the offer. The date for opening of second envelope (Price bid) shall be communicated subsequently. Second envelope of only those bidders shall be opened who qualify in the technical bid. If necessary, the firms may be called for Technical Presentation of their product as per the time intimated by Block Development Officer, Barkote and submission of samples of SLS.

Any clarification on the technical specification and commercial terms and conditions may be clarified in writing from Block Development Officer, Barkote.

Deviation of any commercial terms and condition and technical specification shall not be entertained under no circumstances.

Bidders may in their own interest visit the sites and undertake field survey before submitting bids. Block Development Officer, Barkote

will not be responsible for any incidental or consequential losses of the firms while execution and till expiry of the period of CMC.

All the bidders shall essentially indicate the break-up of prices as shown in Price bid.

During the warranty period State Agencies/ Users reserve the right to cross check the performance of the systems with the minimum performance levels specified in the specifications.

5 Acceptance/ Rejection of the bid documents

The Block Development Officer, Barkote reserves the right to

- i) reject or accept any or all bids without assigning any reason thereof.
- ii) to split the quantities against the bid on more than one firm for the same items/ work.
- iii) cancel the tender without assigning any reason thereof.
- iv) alter or delete any of the terms and conditions mentioned in this document during the process of tender till finalization.

No reason will be assigned by Block Development Officer, Barkote for this and the same will be binding on the bidders.
