- The Divisional Forest Officer, Deogarh Forest Division, Deogarh on behalf of the Governor of Odisha invites **Percentage Rate bids in Single cover system (Composite) online mode** for the construction of civil works as detailed in the table, from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grade / Class Registered with Central Government / MES / Railways for execution of Civil, E.I & G.P.H and Sanitary Works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government, Odisha has to register under the state PWD in appropriate class of eligibility before award of the work.

3. Bid documents consisting of specifications, the schedule of quantities and the set of terms & Conditions of contract and other necessary Documents can be seen in the website www.tendersodisha.gov.in /www.odishaforest.in/www.deogarh.nic. in.
4. i) The Bidders are requested to submit a Bid Security declaration (Schedule-K) along with Bid as per the office Memorandum No.4710 dt.12.4.2022 of Works Department, Govt. of Odisha in lieu of Bid Security in the format mentioned in DTCN.
ii) Bidders desirous to hire machineries or equipment's from outside the State or owned but deployed outside the state are required to transfer online 1% of the amount put to tender as Bid security.
5. The Bidders shall transfer online the cost of Bid Documents as mentioned in **Col.7** of table above towards the cost of bid through a process as mentioned under DTCN.
6. The Bid documents such as DTCN / BOQ etc. can be seen / downloaded from the Govt. Website www.tendersodisha.gov.in /www.odishaforest.in / www.deogarh.nic.in **from 27.09.2022 to 17:00 Hours of 11.10.2022 for online bidding.**
7. The technical bids will be opened at **11:30 Hours of dt. 14.10.2022** in the office of the Divisional Forest Officer, Deogarh.
8. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
9. Bids shall be received only in "**On-line**" mode on or before **16:00 Hours of 11.10.2022.**
10. Bids received through "**on-line**" mode shall be **opened at 11:30 Hours on 14.10.2022** in the office of the Divisional Forest Officer, Deogarh Forest Division, Deogarh in the presence of bidders or their authorized representatives who wish to attend. Bidders who will participate in the bid can witness the opening of bids after logging into the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
11. Bidders are to submit only the original BoQ uploaded by Publisher after entering the relevant fields without any alteration / deletion / modification. Multiple BoQ submission shall lead to cancellation of the bid.
12. The Authority will not be held responsible for any technical snag or network failure during on-line bidding.
13. Other details can be seen in the bid documents.
14. The authority reserves right to cancel any or all bids without assigning any reasons thereof.
15. The addendum / Corrigendum if any will be hosted in the website only.
16. The intending bidders are required to furnish their e-mail address and cell phone number to inform them any message relating to the tender.
17. Engineering contractors who are desirous to avail the facility of exemption of EMD/ISD are required to submit the scanned copy of affidavit along with bid documents to the effect that he/she had not yet availed the facility during current financial year as per codal provision.
18. The SC/ST contractors willing to avail the facilities as fixed by Govt. will submit scanned copy of the affidavit for the same along with tender documents; otherwise, they will not be entitled to avail such facilities.
19. Additional performance security shall be submitted by the successful bidder when the bid amount is less than the estimated cost put to tender as per DTCN clause.
