In Pursuance of Orissa Lower Excise Services (Method of Recruitment and Conditions of Services) Rules, 2011 and subsequent amendment Rules made thereof, the following 08 (Eight) candidates, who have come out successful in Combined Recruitment Examination (CRE)-2021 pursuant to advertisement No-III-E-121/2021-999(C)/OSSSC dt.30.09.2021 conducted by Odisha Sub-Ordinate Staff Selection Commission, Bhubaneswar and subsequent instruction made thereof vide Letter No.IIE-63/2022/2228/OSSSC dtd.30.12.2022 of Joint Secretary, Odisha Sub-ordinate Staff Selection Commission are hereby temporarily appointed to the post of **Excise Constable** in **Deogarh District** on **regular basis** in Cell-1, Level-04 of the first schedule of the Pay Matrix under Odisha Revised Scale of Pay Rules, 2017 as per Odisha Group-“C” & “D” post (Repeal and Special Provisions)Rules, 2022 notified vide GA & PG Department Notification No-PT1-GAD-SC-GCS-0090-2022-29076/Gen dt. 16-10-2022.

They shall be on probation for a period of 02 (Two) years and their appointment is purely temporary and subject to the verification of character and antecedents. On receipt of adverse report on character and antecedents at any point of time during the said period, their services shall be terminated forthwith in accordance with the provisions laid down in sub-clause (II) of clause (h) of Explanation under Rule-13 of the Odisha Civil Services CCA (Classification, Control and Appeal), Rules, 1962 reinforced in GA Department Resolution No-34438/Gen dt.20.11.1999.And the Excise Commissioner, Odisha, Cuttack letter No. 20561/Ex. Dtd. 31-12-2022 and Letter No.75/Estt., Dt.03.01.2023 of The Collector & District Magistrate, Deogarh.

4. Oath of Allegiance to the Constitution of India.
5. Attestation from in duplicate along with two passport size photographs duly attested by a Gazetted Officer.
6. Original Caste Certificate / Resident Certificates issued by the Competent Authority.
7. Two copies of Passport size photographs.
8. Certificate to the effect that he has not more one spouse living in case of married person.
9. An affidavit to the effect that he has not been convicted/involvement in any criminal offence.
