Quotation call Notice

Sealed quotations are invited by speed post/Registered post only from interested reputed Travel Agencies/Tour Operators or Private Individuals within the jurisdiction of Deogarh District for providing One Diesel/Petrol driven vehicle having sitting capacity not more than ten including driver (Scorpio/Bolero/TUV300/Ertiga/Sumo Gold or any other higher model) which shall conform to the Terms and condition (Annexure-I) for official use of BDO, Reamal on monthly rent basis. The terms and condition are as follows:

1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage permit, proof of up-to-date tax payment etc. which are mandatory for paying of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account payee Bank draft from any of the Nationalized Bank drawn in favour of "Block Development Officer, Reamal" payable at Reamal along with the quotation as security deposit. After completion of quotation process, the amount will be refunded to the unsuccessful bidders.
5. The monthly rate of hire charge & kilometers per litter to be quoted separately in the general bid information (Annexure-III)
6. The vehicle must achieve a fuel efficiency of minimum average mileage of 10 KMs per litre.
7. The details of the make and year of manufacture of the vehicle, registration no mileage (Kms. Covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation (Annexure-III).
8. The Quotation completed in all respect should reach the office of the Panchayat Office, Reamal, At/PO- Reamal, Dist- Deogarh, PIN- 768109 on or before 16/03/2023 by 3.00 PM and shall be opened on the same day at 4.00 PM in presence of the bidders or their authorized representatives.
