6. Proof of documents (Certificates/ citation) if any in support of good track of record regarding the functioning/ activities of the organization.

Further the applicant NGOs are advised to submit their applications and other requisite documents in a sealed envelope to the District Social Security Officer, Deogarh, SSEPD Section, Collectorate, Deogarh, PIN-768108, before **dt.17.04.2023 by 1:30 PM** by registered Post/ Speed Post/ Courier/ Hand. Applications shall not be received after completion of the given period of time. The District Management Team will evaluate the documents submitted by the Agencies & select the PIA for DDRC.


