

Tender Notice for Disposal of Un-Serviceable Instrument, Equipment, Furniture & Bedding Clothing items of DHH, Deogarh

Sealed Tenders are invited for disposal of un-serviceable Instrument, Equipment, Furniture & Bedding Clothing items lying at DHH, Deogarh. Intending bidders may obtain Tender paper containing Terms & Condition, details of items and its off-set price in the District NIC website i.e. www.deogarh.nic.in. Also they may inspect the said items to be disposed of in "as is where is conditions" on any working day during the office hours at the designated locations. The sealed tender papers to be submitted to the CDM & PHO, Deogarh on or before **11.09.2023** by Regd. Post/ Speed Post up to 01 P.M and the same will be opened on **13.09.2023** at 11 A.M in the Office chamber of CDM & PHO, Deogarh.

The authority reserves the right to accept or cancel any or all Tenders without assigning any reason thereof.

Terms & Conditions for Disposal of un-serviceable Instrument, Equipment, Furniture & Bedding Clothing items through Tender Call Notice.

1. Concerned items are to be disposed of as per the statement annexed.
2. The participants may inspect the items during the official working hours with permission from the CDM & PHO, Deogarh.
3. Items will be auctioned in "as is where in basis".

TENDER FORMS: -

- The terms, conditions and guidelines for Bidders should not be submitted with the TENDER FORM. Only filled up Tender form (Annexure-1) should be submitted.
- Any mistake noticed in the Tender Form will be decided by the Tender Screening committee and its decision will be final.
- The bidders shall quote the rate visibly in words (Block Letters & Numerical) to avoid confusion.
- The Tender Paper shall be submitted in sealed cover super scribed as "TENDER FOR DISPOSAL OF UN-SERVICEABLE EIF AND BCL ITEMS". Also mention detail address on the left side of the cover with their Telephone No. / Mobile No. etc.
- All bidders shall submit the Tender by Regd. Post/ Speed Post only.

A. Tender Paper Cost:-Rs. 1500/- per Tender shall be deposited in favour of Non NHM RKS DHH, office of CDM & PHO, Deogarh in shape of Bank Draft from any Nationalized Bank.

B. EARNEST MONEY:-

- **Rs. 5,000/-** (Rupees FiveThousandonly) will be treated as EMD and the same will be submitted along with the Tender Form. This will be drawn in favour of Non NHM RKS DHH, office of CDM & PHO, Deogarh from any Nationalized Bank.
- To facilitate immediate refund of EMD, the bidder should submit separate Bank Draft for EMD and Tender Paper Cost. The EMD of 2nd (Second) highest bidder shall not be refunded until the successful bidder deposit the full amount and Tender is finally decided in his favour.
- EMD of unsuccessful Bidder will be refunded after finalization of Tender and within 30 days. No interest can be claimed by the Bidder for the EMD amount.
- Retention of EMD of the highest and second highest Bidder does not guarantee any decision in favour of the Tenders. Decision of the Conducting Authority shall be final.
- The Bidder quoting the highest price approved by the Authority will be asked to deposit 25% of the Tender value on the day of opening of Tender by open announcement.
- On failure to make final payment (75%), the aforesaid deposit of 25% including the EMD of the Bidder shall be forfeited and the items put to fresh auction or Tender as the case may be.
- The Bidder should clearly mention their Name & Designation, whether they may be Govt. /Private Organization.

C. PAYMENT ETC:-

- On payment of total amount, clearance will be issued by the CDM & PHO, Deogarh.
- The EMD of successful bidder will be adjusted in final payment of bidding amount.
- No disposed-off value will be accepted without the presence of the successful bidder of their Authorized agents.
- The condemned items will be handover to the successful bidder on receipt of full payment of the accepted Disposed-off value within 7 days of the approval of the offer.

- The successful bidder shall have to take the items from the respective sites within 7 days of finalization of Tender process. Custody and safety of the disposed-off items shall be responsibility of the successful bidder after it is finalized.

D. GROUND RENT: -

- In case where the items are not taken within the stipulated period, Ground rent@1% of the Auction value shall be charges for each day or part of the day till the items are removed from the site.
- Where the ground rent to so charges exceeds the sale price deposited by the Tenderer then he is ceased to have any right on the items. The amount deposited by him shall be adjusted towards the ground rent & the items shall become absolute property of Governments & free from encumbrances and may be deposited by fresh Tender or as per decision of conducting Authority.

E. DISQUALIFICATION: -

A Tender may be summarily rejected by the Screening Committee for the following reasons.


- Tender not submitted on the prescribed Tender Form.
- Tender received beyond the last date & time as stipulated.
- Tender not submitted in sealed Cover.
- EMD failing short of stipulated amount or without EMD.
- Sealed Tender paper of any of the absentee Tenderer may not be opened & returned to them with seal intact within 30 days.

F. CORRESPONDENCE: -

All correspondence including the legal complication on the Tender and disposal of the items are to be complied by the concerned CDM & PHO, Deogarh.

G. AUTHORITY: -

- The Authority reserves the right to accept or cancel any tender or all tenders without assigning any reason thereof & may settle the auction with the highest bidder on negotiation.
- In case of dispute or any matter the interpretation & discussion of the authority shall be final & binding and the legal procedures if any should be in the Jurisdiction of Deogarh.
