### QUOTATION/ SHORT TENDER CALL NOTICE


Sealed Quotations/Tenders are invited from interested reputed Painters/Painting Agencies/ Art Agencies for wall painting on various ARD sector schemes at 70 Gram Panchayats of Deogarh District, which shall conform to the Terms and conditions (Annexure-I) through O/o Chief District Veterinary officer, Deogarh.

### Terms, Conditions & Scope of work

### Annexure-I

- The person /Agency should have valid PAN & GST number with up to date GST return.
- The agency/ person should have two years experience in wall painting in Govt/ PSU. (experience certificate and work order to be furnished)
- The agency/ person should have registration certificate.
- The content of wall painting will be provided by CDVO, Deogarh to the successful bidder.
- At least one wall painting per Gram Panchayat, preferably at Gram Panchayat Head Quarters and conspicuous places will have to be done.
- The wall painting shall be preferably of 8ft x 5ft size with colour back ground and multi colour painting with weather coat paint.
- The wall painting shall be done with **weather coat paint**.
- The number & size of wall paintings are changeable as per availability of walls i.e. more than one wall painting may be done in a GP, and expenditure shall be made in a proportionate manner as per their sizes and numbers.
- The wall paintings in all the 70 Gram Panchayats of Deogarh District are to be completed by 15 days from the approval bid i.e., by 12.01.2024
- The person/agency will select the site of the wall paintings in consultation with the DD, DVH, Deogarh/ BVO Barkote/ BVO Reamal as the case may be.

- After completion of the wall paintings the person/ agency shall provide post card size Geo-tagged photos of each wall paintings clearly showing the location of the paintings to the concerned Block Veterinary Officers and DD DVH as the case may be, as proof of completion of wall painting work.
- Payment will be made to the person / agency after certification of the Geo-tagged photographs by the concerned DD DVH, Deogarh/ BVO Barkote/ BVO Reamal as the case may be.
- A sum of **Rs.10000/- (Refundable)** shall be deposited by the intending bidders in the shape of **Account Payee Bank Draft drawn in favour of the CDVO, Deogarh**, payable at Deogarh and submitted along with the quotation/tender as security deposit. After completion of the tender process the amount will either be refunded to the unsuccessful bidders or adjusted against the final payment to the successful bidder.
- In case the application is downloaded from the Govt. website the applicant/agency shall furnish a demand draft of **Rs.500/- (Non refundable)** towards the cost of EMD issued **in favour of the CDVO, Deogarh, payable at Deogarh** or deposited in the **SBI, Deogarh current Account No.30109636542 of CDVO Deogarh**.
- If the bidder violates any of the terms of the contract, CDVO Deogarh will forfeit the entire amount of the security deposit.
- The interested parties / agencies / individual are required to apply to the undersigned in the specified format/ form as in the advertisement (Annexure-II).
- All pages of the documents are to be serially numbered and bear signature of the bidder / his authorized person.
- The quotation/ bid completed in all respect should reach the undersigned on or before Dt-28.12.2023 at 1.00 PM by post or by person and shall be opened on Dt-27.12.2023 at 3.00 PM in the presence of the bidders or their authorized representatives.
- The Authority shall not be responsible for any postal delay or if bids are received beyond the designated date & time.
