## ENGAGEMENT ORDER



**The engagement is subject to the following terms and conditions given below:**

1. The engagement is purely contractual and can be terminated in any time without any notice and assigning any reason thereof.
2. The selected candidates are required to submit their joining report to the Collector-cum-CEO, Zilla Parishad, Deogarh within a period of one month from the date of issue of this engagement order failing which his/her candidature will be rejected. Soon after submission of joining report in the district they have to join in the respective Block as well as Gram Panchayat concerned.
3. The GRS are engaged on contractual basis for a period of one year. On the basis of the satisfactory performance and recommendation by the BDO, the contract of GRS may be renewed for another one year by the Collector-cum- CEO, Zilla Parishad, Deogarh and so on.
4. The GRS will be paid a consolidated monthly remuneration of Rs. 7000/- (Rupees Seven Thousand only) which will be revised with the approval of Govt.in PR&DW Deptt.,Odisha.
5. This is a "District Cadre" post and is transferable in nature within the concerned District. The Collector-cum-CEO, Zilla Parishad is competent to transfer the GRS from one Gram Panchayat to another Gram Panchayat within the District in view of exigencies of public service or in consideration of genuine grievance or on administrative ground.
6. A GRS may tender his/her resignation from the post by giving minimum one month prior notice to the Collector-cum-CEO, Zilla Parishad through the concerned BDO.
7. Collector-cum-CEO, Zilla Parishad is the Disciplinary Authority of the GRS and is competent to terminate the contract and disengage the GRS.
8. If any fraudulent testimonial is detected in future or if he/she has been criminally prosecuted, the agreement shall be cancelled without notice and action as deemed proper will be taken against him/her as per the provision of law.
9. The candidates should submit the following certificates and documents at the time of joining.
  - (a) Two character certificates from Officers not below the rank of Group- B Officers.
  - (b) Medical Certificate of Fitness from Govt. Medical Officer not below the rank of the Asst. Surgeon.
  - (c) Oath of allegiance to the Constitution of India as prescribed.
  - (d) A declaration to the effect that, he/she has not more than one spouse living and if his/her statement is found incorrect or he/she has more than one spouse living he/she shall be liable for dismissal.
