Short Quotation Call Notice

Sealed quotations/tenders are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing 01 (one) no. of AC Petrol/Disel Bolero/ TUV300 vehicle having seating capacity of not more than seven including driver, which shall confirm to the Terms and Conditions (Annexure-B) for official use in the District Election Office, Deogarh on monthly rent basis.

1. The service provider shall have a valid OGST registration to participate in the tendering.
2. The vehicle must be in road worthy condition, shall not be more than 3 years old from the date of initial registration certificate, insurance certificate, fitness certificate, valid contract carriage permit, proof of up-to-date tax payment etc. which are mandatory for plying of vehicle.
3. The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport /passenger vehicle.
4. The driver should be well behaved, gentle and obedient in nature.
5. *An amount of Rs. 1000/- as Tender Processing Fees (non-refundable) and an amount of Rs. 5000/- as EMD shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the DEO and Collector, Deogarh. After completion of tender process, the EMD amount will be refunded to unsuccessful bidders.*
6. The monthly rate of hire charges is to be **up to Rs 31000/- as per the Finance Deptt. Govt. of Odisha Office Memorandum No. 22924/F Dtd.14.08.2023** to be quoted separately in the general bid information (excluding fuel and lubricant).
7. The vehicle must achieve minimum fuel efficiency of 10 kms per litre.
8. The details of the make and year of manufacture of the vehicle, registration No. mileage (KMs per litre) and name of the driver with driving license No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender (**Annexure-A**).
9. The quotation in all respect should reach the undersigned on or before **16.01.2024 by 02.00 P.M and shall be opened on the same day at 04.00 P.M before the selection committee** in presence of the bidders or their authorized representatives.
10. The application form of quotation/ tender contacting General Bid information & terms and conditions for hiring of vehicle etc. can be downloaded from Deogarh District website www.deogarh.nic.in from dated **05.01.2024 to 12.01.2024**.

TERMS & CONDITIONS FOR HIRING OF VEHICLE

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicle during period of contract shall have all necessary valid MV documents such as valid Registration Certificate, Insurance Certificate, Pollution Certificate, Fitness Certificate, Valid contract Carriage Permit, Proof of up-to-date tax payment etc. and driving license of the driver available all the times.
2. The District Election Office, Deogarh shall not be responsible for any damage/loss caused to hired vehicle i.e loss of life/injury made to any person or damages to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
3. The hire charge to be paid for monthly basis is final but does not include cost of fuel, which is to be paid separately basing on actual consumption as per existing Government norm. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of Engine, Gear Box & differential Coolant, Tyres and tubes, Battery etc. will be borne by the bidder.
4. It shall be the responsibility of the bidder to provide a good driver and the remuneration of the driver shall be borne by the owner.
5. In case of breakdown for reasons, whatever the replacement of vehicle of the same or better model shall be provided by the owner of the vehicle/bidders.
6. *In case of the vehicle do not report regularly, the Authority will be at liberty to terminate the agreement without prior notice and may engage vehicle from other sources.*
7. The vehicle shall report for duty for minimum of 25 days in a month.
8. In case of emergency, the driver will have to report for duty as per the requirement. No extra payment shall be demanded.
9. Monthly hire charges and reimbursement towards cost of fuel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provider and no advance will be paid.
10. The vehicle shall not be more than 03(three) years old from the date of initial registration and also should be in good running condition during the period of contract.
11. *If the services are found to be unsatisfactory, the bidder shall be given one month notice and the agreement shall be terminated.*
12. In case the service provider intends to withdraw the services of his/her vehicle and terminate the agreement, it shall be mandatory upon him to give one month notice of such withdrawal of service and termination of agreement.
13. **Authority reserves the right to cancel any or all the Quotation without assigning any reason thereof.**
