
(3) forms of nomination paper may be obtained at the place and time aforesaid;

(5) notice of withdrawal of candidature may be delivered either by a candidate or by any of his Proposers or by his election agent who has been authorised in writing by the candidate to deliver it to Returning Officer, 19-Deogarh Assembly Constituency & Sub-Collector, the officer specified in paragraph(2) above at his office before **3 P.M. on the 09.05.2024(Thursday)**;

(6) in the event of the election being contested, the poll will be taken on **25.05.2024(Saturday)** between the hours of **7.00 AM and 5.00PM**.
