This is to notify whomsoever it may concern that with reference to "Request for Proposal" (RFP) invited towards selection of event management agencies for executing various activities in the District level Matsya O Pranee Sampad Mela-2024 in the District website– www.deogarh.odisha.gov.in, the following additions/ deletions/ alterations are to be inserted as mentioned below.

1. In page No.14 under the column "bid evaluation parameters" in Row No.3 in place of "Documents digitally signed" the following is replaced or inserted i.e. "Documents digitally signed or self attested". The maximum marks assigned will remain 10 in both the cases i.e. Documents digitally signed or self attested. Not withstanding anything mentioned any where in the RFP document this statement i.e. Documents digitally signed or self attested is final.
2. All pages submitted by the bidders in the RFP proposal should **compulsorily be either digitally signed or self attested.**
3. In "preliminary evaluation (1st Stage)" in Page No.13 the documents submitted in technical bid is sufficient (No extra document/ copy for preliminary evaluation may be submitted) and they should match all the documents to be scrutinized under preliminary evaluation (1st Stage). **Non qualifying the preliminary evaluation (1st stage) as mentioned in Page No.13 is same as non qualifying the technical evaluation (2nd stage) as mentioned in Page No.14.**
4. In Sl. No.12 "point d" of Page No.22 and in Sl. No.30 of Page No.24, the cash award of Rs.5000/- to be paid as felicitation to each of the 08 awardee farmers amounting to a total of Rs.40,000/- will be paid by the RFP inviting authority. Hence the maximum value of the tender / RFP proposal **should not exceed Rs.21.60 Lakh including GST.**
5. In Page No.12 & Sl. No.16 the **maximum value of the Tender / RFP proposal should be read as Rs.21.60 Lakh including GST instead of Rs.22.00 Lakh.**
6. **Application of bidders quoting beyond Rs.21.60 Lakh including GST in their Bid proposal will be summarily rejected. The maximum value of the RFP proposal should under no circumstance exceed Rs.21.60 Lakh including GST.**
7. In Page No.9, Sl. No.1 (Technical Bid cover A) and point No.2 the sample / format for submitting index of documents along with the bid documents is attached below.
