



**I. TERMS AND CONDITIONS OF TENDER FOR TENT & ALLIED WORKS**

1. The bidders are required to deposit the E.M.D. of Rs. 14, 000/- (Rupees fourteen thousand only) in shape of Bank draft in favour of "Chief District Agriculture Officer, Deogarh" from any Nationalized Bank. The E.M.D. of the successful bidder will be kept with Chief District Agriculture Officer, Deogarh till the completion of the exhibitions i.e. for a period of one month. In case of any dissatisfactory work, delay in execution of work etc. the E.M.D will be forfeited as per the decisions of the authority. Tender papers without E.M.D shall not be accepted.
2. **The bidders should have registered his firm under Goods & Services Tax (GST), PAN.**
3. **The rate offered by the firm shall be including GST as applicable.**
4. Average Annual Turnover of last three years should be submitted with application form.
5. The duration of the exhibition will be for 5 days. All the desired works should be completed at least one day before the scheduled date and time of the inauguration of exhibition and should be handed over all the works as per specification, to the I/C event management of exhibition.
6. The bidder shall quote their price for all the items without leaving blank. If found so, the bid will be treated as non-responsive and shall liable to be rejected.
7. The bidder has to quote the rate as per the given format.
8. On completion of the exhibition, the contractor shall have to take away all the materials within eight days & vacate the place with the same condition while occupying the ground.
9. The contractor should be prepared to provide additional materials in case of requirement at the market price for the items not mentioned in the tender.
10. The final payment will be made on the basis of the actual work done and Work Assessment Report in the specified format by the CDAO Deogarh. ### A. ERECTION OF STALL (50 numbers of stall)

The details of specifications are given below:


