The tender shall be received by the DSWO, Deogarh on behalf of Collector, Deogarh till **20.2.2025** by **5.30 P.M.** and will be opened on **21.2.2025** at **04.00 P.M** in the Office Chamber of Collector, Deogarh in presence of Tender Committee members and the Tenderers or their authorized representatives by producing the letter of authorization. The tender received beyond the date and time shall be liable for rejection.



As per revised guidelines for implementation of Take Home Ration – vide letter No- 2297/WCD. Dtd. 27.1.2025 under SNP the ceiling limit for transportation charges of wheat from FCI, Sambalpur Depots to WSHG Points and Rice from OSWC Godown, Tileibani to different AWCs is **Rs.150.00 (Rupees One Hundred Fifty) only/- per quintal.**



TERMS AND CONDITIONS OF THE TENDER


1. The Tenderer shall carefully go through all the terms and conditions of the tender documents and submit the tender paper correctly and in complete form. The tender paper should be filled in properly and legibly without any correction/overwriting. No opportunity shall be given to the tenderer to rectify or amend any defect deleted at the time of scrutiny. The rates should be written both the words and figures in the tender schedule. The rate quoted should be final and the tenderer shall not be allowed to change the same under any circumstances and it should be valid for the year 2025-26.
2. No individual company, firm, corporation shall participate in the tender process unless it obtained or possess valid Agent License under OMV (licensing Agent) Rules 1990. (This is exemption for WSHGs.)
3. The successful tenderer shall be required to lift Wheat from F.C.I Depot Katapali/Gadbhanga/Hirakud /Kalamati/ Balijori and Rice from OSWC Godown, Tileibani, Deogarh and transport the same to different WSHGs/ Anganwadi Centre points respectively as per the direction of the Collector/DSWO, Deogarh within the specified period. After lifting the wheat from F.C.I Depot and rice from OSWC godown, the wheat /rice will be delivered at the WSHG points/Anganwadi Centres on the same day without any storage during transit.
4. It is responsibility of the transporting agent to lift the rice from OSWC Godown on proper weighthment and deliver the same to the AWWs on proper weighthment in the presence of the member of the Janch Committee and in no case short supply or delivery shall be made by the agent to the AWWs. The weighthment machine to be carried by the transporting agent must be sealed and stamped by the inspector of the Legal Metrology, Deogarh The agent will be held responsible to taking delivery of the stock, shortage and damage noticed if any during transit and no shortage will be allowed to the agent. The quality and quantity of the foodstuff being transported may be inspected by the Government Official authorized by Collector during transit and also at the delivery point. There shall not be any change both in quality and quantity of the food grains during transportation by the transporting agent and for any shortcoming in this front the transporting agent. If any misappropriations is noticed during inspection or otherwise a penalty shall be levied which would be equivalent to 10 times of the cost of misappropriated food grains apart from initiating criminal cases.
5. The tenderer should submit the following documents along with the tender paper. In absence of any documents /paper in the tender form will be liable for rejection by the competent authority. The tenderer shall have to produce the original document if necessary before the Tender Committee for verifications.
 - i) Original tender paper duly signed by the tenderer as token of acceptance of the terms and conditions of the tender.
 - ii) Attested copy of the Valid Agent License owned by the tenderer under Orissa Motor Vehicle (Licensing Agent) Rules, 1990 for Deogarh district.
 - iii) Attested copy of the valid Income Tax/ Pan Card.
 - iv) Recent Solvency Certificate for **Rs.5,00,000/-**(Rupees Five lakhs) only from the Competent Authority should be furnished along with the tender paper failing which the tender will be liable for rejection. (This is exemption for WSHGs.)

- iv) Certificate of past experience at least one year for the District Collector/ any Government Organization in handling /Storage transport work to be furnish along with the tender paper. The accepting authority shall have the right not to accept tender of registered firm/authorized licensing Transport Contractors / Agents who have not performed satisfactorily in the pending year under Government of Odisha.
- v) Earnest Money to the tune of Rs.1,00,000.00 (Rupees One lakh) only in shape of TD/ FD/NSC/KVP etc duly pledged in favour of **District Social Welfare Officer, Deogarh** shall be furnished along with tender. Tenders without Earnest Money will be liable for rejection, Cash/Cheque and Bank Draft shall not accepted .No request for transferor or any previous deposit on adjustment of earnest money for any claim payable will be entertained. Any deviation to the above stipulation will entail complete rejections of the tender paper. No tenderer shall be allowed to withdraw his tender / Earnest Money Deposit until the tender is finalized .In case the successfully tenderer refused to be Transporting Agent after acceptance of his tender, the Earnest Money Deposited by him will be liable for forfeit.
- vi) The E.M.D. of the unsuccessful tenderer shall be refundable after finalization of the tender, whereas the E.M.D of the successfully tenderer will be kept as security deposit and will be released after successful completion of contract period, settlement of payment thereof and audit of such account and after obtaining the audit report. The Collector/DSWO, Deogarh is not liable for payment of any interest of security deposit or any depreciation thereof. The branch of any terms and conditions as per agreement and failure/ unwillingness to undertake transportation work by the selected tenderer within the time limit after acceptance his tender may lead to forfeiture of E.M.D .The tenderer shall not be blacklisted by the Government.
- vii) The tenderer or any of his family members should not be storage Agent/Miller /Agent/Retailer of P.D.S, Rice .An affidavit to this said effect is to be furnished along with the tender paper.
- viii) The tenderer should file an affidavit either from the Executive Magistrate or from Notary in support of that he/ she have no criminal background.
6. The successful tenderer shall have to enter into registered agreement with the DSWO, Deogarh as per the terms and conditions mentioned in the specified agreement format within 7 days of intimation of acceptance of his tender.
7. Payment shall be made against submission of bills on completion of the delivery of the stock as per the orders of competent authority on production of printed serially numbered delivery Chalans duly acknowledge by the recipient(s) of the stock to whom it converted as per the approved rate incorporated in the agreement. The District Social Welfare Officer, Deogarh shall have the right to deduct and adjust any amount found recoverable towards loss and damage or both. The payment will be made subject to availability of funds under transportation Charges head under SNP feeding Programme and no advance payment will be made.
8. Good conduct, dealing with official shall be an implied condition for continuance as Transporting Agent.

9. The Collector, Deogarh may terminate the contract for violation of terms and condition of agreement as well as any charge of policy in the Government or of any reasons to be recorded in writing.
10. In case of violation of condition of Tender the Agent will be booked under IPC, Essential Commodities Act., Prevention of Food Adulteration Act. and Prevention of Black Marketing Act.
11. The right of acceptance of tender rests with Collector, Deogarh who does not bind himself to accept the lowest tender and also reserves the right to cancel or reject any or all the tender without assigning any reason thereof. In case of any dispute the order/decision of the Collector, Deogarh will be final and binding.
12. The tenderer must have GST number and will be submitted the latest GST return certificate. (Exemption for SHG).
13. The tenderer must submit the IT Return Copy of last 3 Assessment years (2021-22, 2022-23 & 2023-24). (Exemption for SHG).

2. The bills will be submitted on completion of delivery of stock as per orders of the competent authority on production of printed serially numbered delivery chalans duly acknowledged by the recipient(s) of stock to whom it concern with other documents to concern CDPOs or accounts and stock entry at their level. The CDPO will furnish consolidated report/statement on total quantity of rice stock received in a particular month which should be enclosed by the transporter along with claim bill and submit in the Office of the DSWO, Deogarh. The DSWO have the right to deduct and adjust any amount found recoverable towards loss or damage of the rice.
3. The Collector, Deogarh may terminate the contract for violation of terms and conditions of the Agreement.
4. The payment shall be made as per approval rate incorporated in the agreement.
5. No request for enhancement of the approved rate shall be entertained during the terms and agreement /Contract.
6. The successful Agent should carry weighing scale and its devices in his cargo and give delivery of foodstuff the Anganwadi Centre Points on proper weightment in presence of AWW / Janch Committee /Mothers Committee members. Delivery of stock intermediate point is not allowed.
