1. The Divisional Forest Officer, Deogarh Forest Division, Deogarh on behalf of Governor of Odisha invites Percentage Rate bids in Single cover system (Composite) online mode for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grade / Class Registered with Central Government / MES / Railways for execution of Civil, E.I & G.P.H and Sanitary Works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government, Odisha has to register under the state PWD in appropriate class of eligibility before award of the work.
2. The bidders may submit bids for any or all of the following work separately.



Bid documents consisting of specifications, the schedule of quantities and the set of terms & Conditions of contract and other necessary Documents can be seen in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) / [www.odishaforest.in](http://www.odishaforest.in) / [www.deogarh.nic.in](http://www.deogarh.nic.in) . Bidders desirous to hire machineries or equipment's from outside of the State or owned but deployed outside the state are required to transfer online 1% of the amount put to tender as Bid security.
4. The Bidders shall transfer online the cost of Bid Documents as mentioned in Col.7 of table above towards the cost of bid through a process as mentioned under DTCN.
5. The Bid documents will be available in the website [www.tendersodisha.gov.in](http://www.tendersodisha.gov.in) / [www.odishaforest.in](http://www.odishaforest.in) / [www.deogarh.nic.in](http://www.deogarh.nic.in) from 11:00 Hours of 12.06.2025 to 17:00 Hours of 21.06.2025 for online bidding.
6. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
7. Bids shall be received only on "On-line" on or before 17:00 Hours of 21.06.2025
8. Bids received "on-line" shall be opened at 11:00 Hours on 23.06.2025 in the office of the Divisional Forest Officer, Deogarh Forest Division, Deogarh in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging in to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
09. Bidders are to submit only the original BoQ uploaded by Publisher after entering the relevant fields without any alteration / deletion / modification Multiple BoQ submission shall lead to cancellation of bid.
10. As it is a percentage rate tender, the bidder quoting zero value is valid and will be taken as schedule of rates.
11. The Authority will not be held responsible for any technical snag or network failure during on-line bidding.
12. Other details can be seen in the bid documents.
13. The authority reserves right to cancel any or all bids without assigning any reasons thereof.
14. The addendum / Corrigendum if any will be hosted in the website only.

15. The intending bidders are required to furnish their e-mail address and cell phone number to inform them any message relating to the tender.
16. Engineering contractors who are desirous to avail the facility of exemption of EMD/ISD are required to submit the scan copy of affidavit along with bid document to the effect that he/she had not yet availed the facility during current financial year as per codal provision.
17. Additional performance security shall be submitted by the successful bidder when the bid amount is less than the estimated cost put to tender as per DTCN clause.
18. Other details can be seen in the bidding documents.
19. If the rate quoted by the SC & ST category come to 14.99% (decimals up to two numbers will taken for all practical purpose) less than the estimated cost after availing 10% price preference as per Para-2 works Department Resolution No.27748 dt.11.10.1977, than the tender shall be finalized by the tender accepting authority through a transport lottery system along with other category of contractors whose rate are 14.99% less than the estimated cost in presence of all bidders/ their authorized representatives.
20. The bidder shall have to furnish "No Relation" certificate in shape of affidavit along with the bid documents to the effect that no officer of the Department to the rank of Assistant Engineer or above is related to him.
21. Clear scanned copies of tender, PAN, Valid and active GSTIN certificate, no relation certificate in shape of affidavit, original valid contractor registration certificate with online registration in CDMS portal. Bid Security Declaration form, affidavit regarding genuineness and authenticity of documents, affidavit to avail price preference in case of SC & ST contractors should be uploaded along with the Bid document.
