The Project Administrator, ITDA, Tileibani on behalf of the Govt. of Odisha, in pursuance to OM No.12586 W Dt.09.09.2022 of Works Department, Government of Odisha invites **Percentage Rate Bids in Online Mode Single Cover System** for the works as detailed in the table, from the class of eligible contractors as mentioned in Column-6 (Six) registered with the State Governments and Contractors of equivalent Grade / Class Registered with Central Government / MES / Railways for execution of Civil Works. The proof of registration from the appropriate authority shall be enclosed along with the Bid.

2. Bid documents consisting of the schedule of quantities and the set of terms & conditions of contract and other necessary documents can be seen in the website www.tendersodisha.gov.in and in the office of the undersigned during the office hours of working days from 10.00 AM of 06.06.2025 to 5.00 PM of 12.06.2025
3. The cost of Tender Paper and EMD as indicated above shall be received online along with the bids as per guideline issued by Works Deptt. O.M. No. 6785, dt. 09.05.2017 and No. 17254, dt. 05.12.2017. The procedure of bid submission using electronic payment of Tender Paper Cost and EMD by the bidder may be referred in Works Deptt. O.M. No. 17254, dt. 05.12.2017, which has been added to the DTCN. Tenderers desiring to hire machineries or equipments from outside the state has to furnish 2% of the amount put to tender as bid security.

4. The Bid documents will be available in the website www.tendersodisha.gov.in from 10.00 AM of 06.06.2025 to 5.00 PM of 12.06.2025 for online bidding.
5. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class III or Class IV with must enrolled in Contractor Database Management System (CDMS).
6. Period of Availability of Tender online / date & time of bidding online / date & time of submission of Bid Documents / date of opening of Bid are as follows.

7. Bids received "online" shall be opened at 9.00 AM on 13.06.2025 on wards in the office of the PA, ITDA, Tileibani, Deogarh in the presence of bidders who wish to attend. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
8. Engineer Contractor who wants to avail EMD Exemption shall have to furnish scan copy of affidavit along with tender, declaring there in that he/she has not yet availed three numbers of EMD Exemption during this financial year and to show the original registration certificate to the tender opening authority for verification without which the tender will be rejected. SC / ST contractors desires of availing benefit as per **Works Department Resolution No. 27748, dt. 11.10.1977** must submit affidavit for the same along with attested copy of Caste Certificate.
9. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the state Government is allowed to work as a Contractor for a period of two years after his retirement from Government service without Government permission.
10. **Amendment to Appendix – IX, Clause – 36 of OPWD Code Vol.-II by inclusion.** If the rate quoted by the bidder is exactly 15% less or more than 15% less of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders / bidders / their authorized representatives/ the Concerned SE/ Executive Engineer of the concerned division and Asst. Executive Engineer will remain present.
11. **Additional Performance Security** (As per Works Department OM No.4559 dt.05.04.2021) shall be obtained from the bidder when the bid amount is less than estimated cost put to the tender. In such an event only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the Additional Performance Security as per the following rate.

The applicable Additional Performance Security (APS) shall have to be furnished by the successful bidder in shape of term Deposit Receipt pledged in favour of Project Administrator, ITDA, Tileibani / Bank Guarantee in favour of the Project Administrator, ITDA, Tileibani from any Nationalized/Scheduled Bank in India counter guaranteed by its local branch at Deogarh within seven days of issue of Letter of Acceptance (LOA) by the Project Administrator, ITDA, Tileibani (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled. Further, proceeding for blacklisting shall be initiated against the bidder. (Vide Office Memorandum No.14459/W dated 20.09.2018 of Works Department, Govt. of Odisha).

12. The bidder has to submit the Cost of Tender Paper and EMD as the amount specified for the work electronically as per Works Department Memo No. 17254, dt. 05.12.2017. Only those bidders, who have successfully, remit the cost of Tender Paper and EMD would be eligible to participate in the tender process.
13. DTCN signed, Affidavit of Authenticity of documents, Bid Security Declaration, GSTIN Registration Certificate, PAN Card, valid Contractor Data Base Management System (CDMS) Registration Certificate & other documents as

mentioned in the DTCN must be clear web-site along with the bid.

14. Other details can be seen in the bid will be followed as per the OPWD codal

15. Any addendum / corrigendum / cancellation www.tendersodisha.gov.in and in the office notice board.

16. The authority reserves right to cancel any or all bids without assigning any reason thereof.


