### QUOTATION CALL NOTICE

The Child Development Project Officer, Barkote invites sealed bids only from the suppliers having valid PAN, GST Registration and authorization/license for supply of Fire Safety Equipment (one sand bucket, one water bucket along with one fire blanket of minimum size 6 ft × 4 ft) for 256 Nos. of Anganwadi Centres (AWCs) under ICDS project, Barkote. The supplier has to follow the instruction as given below.

1. The detailed Quotation Call Notice, description & specification of items and all other terms and condition will be available in Notice Board of CDPO Office/ Block Office/ Tahasildar Office/ Collectorate/ District Web Site "deogarh.odisha.gov.in" with effect from Dated:24.12.2025, Time:11:00AM
2. The Quotations will be received from 24.12.2025 to 30.12.2025 up to 4.00 PM and will be opened on Dated: 31.12.2025 at 11:00AM in the office of the ICDS Project, Barkote in the presence of the Local Purchase Committee & Quotationers or their authorized agents. If the office happens to be closed on the date of receipt/opening of the Quotation as specified, the quotations will be received / opened on the next working day at the same time and venue.
3. The Quotationers are required to furnish the attested photocopy of GST Registration Certificate from appropriate authorities, PAN Card, Bank Account Number & other connected documents along with the Quotation.
4. The Local purchase committee is to select bidder based on rate vis-a-vis quality of the sample. The bidder has to produce the sample before the committee. the committee shall select the bidder producing the best quality if its rate is within Rs. 1000/- (Rupees One Thousand) even in it is higher rate than the other bidder.
5. Statutory deductions of taxes as per prevailing Govt. order such as GST, Income Tax, any other Central Govt./State Govt. Taxes shall be made at source from the bill.
6. The rate Quoted by the Quotationer shall be inclusive of all taxes, duties, transportation & Installation charges. The total cost per unit, inclusive of all taxes, transportation & Installation cost to AWC point, shall not exceed Rs. 1,000/- (Rupees One Thousand only) as prescribed by Government of Odisha, W&CD Department.
7. The undersigned shall not be held responsible for any postal delay or non-receipt if any, in the delivery of the documents or non-receipt of the same. The Quotationer shall not write the ancillary documents submitted on the cover.
8. The selected supplier shall deliver the Fire Safety Equipment at the respective AWC points positively on or before 10.01.2026.
