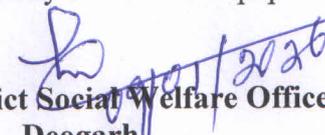

Sealed tender are invited from intending Agencies/Firms/Printing press for supply of the following materials for Anganwadi Centers of the district. The tender documents should reach in the office of the District Social Welfare Office, Deogarh by Registered Post / Speed Post/Courier by **28/01/2026 at 5.30 P.M** and the tender will be opened on dtd. **29/01/2026 at 04.00 PM** in the Conference Hall of Collector & DM, Deogarh in the presence of the Tender Committee constituted for the purpose and the tenderer or their authorized representative. The tender papers received after due date and time will not be entertained. The term & conditions of the printing materials are mentioned at Annexure-I.

The details of the above materials/items are mentioned in the terms and conditions. The materials/items should be of exact specification as per the samples available in www.deogarh.odisha.gov.in The selected agency has to supply the printed materials to all the 03 ICDS Project office of the District at its own cost. The agency has to supply the samples of materials as conditions can be downloaded from the District website <http://www.deogarh.odisha.gov.in>.

The firms/agencies/printing press submitting tender paper by downloading from website have to enclose a Bank Draft amounting of **Rs.2,000/- (Rupees Two Thousand)** only as cost of Tender Paper including GST in favour of DSWO, Deogarh payable at SBI, Main Branch, Deogarh failing which the tender papers will be rejected. An amount of **Rs.5,000/- (Rupees Five thousand)** only in shape of TD/FD/NSC as EMD has to be paid by the tenderer. The TD/FD/NSC should be pledged in favour of District Social Welfare Officer, Deogarh. The same will be refundable to unsuccessful tenderer after finalization of tender and this can be covered as Security Deposit in case of successful tenderer.

TERMS AND CONDITIONS FOR SUPPLY OF NUA ARUNIMA WORK BOOK (I& II), AND CHILD ASSESSMENT CARD .

The sample of the Revised Nua Arunima Work Book I & II , Child Assessment Card can be inspected /obtained , www.deogarh.odisha.gov.in and at the DSW Office during office hour by the interested agencies.

1. The EMD deposited by the successful tenderer will be kept as security deposit and refunded only after audit of accounts. In case of unsuccessful tenderer, the EMD will be returned after finalization of the tender.
2. The tender paper should be submitted along with the following documents failing which the tender paper will be rejected and will not be taken into consideration.
 - a. Original tender paper signed by the tenderer as token of acceptance of terms and conditions.
 - b. Attested copy of valid printing press license from competent authority for printing materials.
 - c. Attested copy of PAN card and GST registration either in the name of printing press or its proprietors.
 - d. Attested copy of upto date GST clearance certificate.
 - e. The EMD amounting to **Rs.5,000/- (Rupees Five thousand) only**- to be given at the time of submission of the tender paper in shape of NSC/TD/FD duly pledged in favour of DSWO, Deogarh separately for each items. No tenderer shall be allowed to withdraw his tender /earnest money until the tender is finalization. The EMD of unsuccessful tenderer shall be refunded soon after finalization of the tender and this can be converted as Security Deposit in case of successful tenderer. The undersigned is not liable for payment of any interest on Security Deposit or any depreciation thereof.
 - f. The firms/agencies/printing press submitting tender paper by downloading from website have to enclose a Bank Draft amounting of **Rs. 2,000/- (Rupees Two Thousand)** only as cost of Tender Paper including GST in favour of DSWO, Deogarh payable at SBI, Main Branch , Deogarh failing which the tender papers will be rejected . Attested copy of DIC Registration certificate /Sales Tax Regd. No.
 - g. Income Tax Return of last 3 Assessment years (i.e . 2022-23 , 2023-24 and 2024-25).
 - h. The tender paper completed in all respect without any cutting /over writing with legible letters with all necessary documents will be received only Regd.Post/Speed post /Courier only addressed to the District Social Welfare Officer, Deogarh on or **before 5.30 P.M Dtd 28.01.2026** .The tender received beyond the date & time shall not be taken into consideration. Hand delivery will not be accepted.

3. The sealed envelope containing the tender papers must be superscribed "Tender Paper for Printing of "Nua Arunima Work Book (I & II) and Child Assessment Card (Mo Bikas Patra) all the documents should be submitted in a master sealed envelope.
4. The price quoted must be inclusive of all taxes duties and T.C. on delivery at ICDS Project of this district . The rate/price should be written both in word and figure item wise in the price bid in a separate closed envelope super scribed as "Price Bid".
5. The tenderers have to produce the samples of each item at the time of opening of tender. The tender Committee is to select bidder based on the rate visa vis quality of the sample. If the lowest bidder sample quality is poor than the other bidder as per decision of Tender Committee, then the bidder whose quality is best, that bidder will be selected for the Tender.
6. The undersigned reserve the right to cancel or modify the tender call notice without assigning any reason thereof. The lowest rate quoted may not be binding for acceptance if it is not good quality. The decision of the tender committee regarding selection of articles/firm will be final. The undersigned also reserves right to increase or decrease the quantities of any book without assigning any reason thereof.
7. The successful tenderer has to deliver items to all the ICDS Project points only within 1 month from the date of receipt of indent order from DSWO, Deogarh .Failure to supply the material may lead to forfeiture of EMD / imposition of penalty.
8. No part payment will be done. Payment will be made through e-transfer only after successful delivery of the items of approved quality duly checked by DSWO, Deogarh. Acknowledgment /receipt from CDPO concerned should be submitted with the bills. Income Tax deduction will be done at source as per Government guideline and the selected tenderer has to indicate SB A/c No, Name of the bank with branch, IFS Code at the time of submission of bill. The payments will be made only on availability of funds and no interest can be claimed in delay payment.
9. The successful tenderer has to give an undertaking that he/she will abide all the terms and conditions of the tender procedure.
10. The agency has to apply in the prescribed format only. Any other format will make rejection of the tender. The agency must submit the check list with proper paging in the technical bid.
11. Detailed of the Nua Arunima Work Book- I & II, Child Assessment card are as follows.

13. The Check list must be fill up and all documents must be paging for smooth verification of the tender documents.

14-Evaluation Process:- Procedure for Opening the Bids:

- a. The Technical bid will be opened first.
- b. Then technically qualified bidders will be allowed to demonstrate the product. The sample will be evaluated with 100 Marks is earmarked for the over all paper quality, print quality and cover type and quality of the cover .
- c. After completion of Technical and Product demonstration evaluation then the financial bid of the technically qualified bidder will be opened.
- d. The committee can reject any sample which are of sub-standard quality and the rejected bidder can not participate in the financial bid.

e. Final Evaluation:

The final evaluation will be done in CQCBS method. Based on the evaluation of technical proposal, the technically qualified bidder shall be ranked highest to lowest Technical Score (ST) in accordance to the mark obtained during the technical evaluation stage. There shall be 50% weightage to technical score and 50% weightage to financial score.

The individual bidder's financial score (SF) will be evaluated as per the formula given below:

$SF = [F\text{-min}/F\text{-bid}] * 100$ (rounded off to two decimal places) where
SF=Normalized financial score of the bidder under consideration
F-min=Minimum financial quote among the technically qualified bidders

F-bid=Financial quote of the bidder under consideration.

Combined Score(S) = $ST * 0.5 + SF * 0.5$

Where ST=Technical Score secured by the bidder.

The bidder securing the highest evaluated combined score(S) will be awarded the contract observing due procedure. For the purpose of evaluation the total evaluated cost shall be inclusive all taxes and duties and transportation cost from manufacturing unit to the AWC point.

The bidder who meets the requirement specified in the technical bid will only be consider for participating in the financial bid. Financial bid of the technically disqualified bidders will not be opened.

- f. If due to any reason the due date is declared as a holiday the bid will be open on next working or as desired by the Authority.
- g. The bid will be opened in the presence of the bidders or their authorized representatives. The authority will not be responsible if the bidder or their authorized representatives is not present.
