





EXPRESSION OF INTEREST FOR DISTRICT OMBUDSMAN UNDER MGNREGS

As per Revised Guidelines for appointment of Ombudspersons of Govt. of India, Ministry of Rural Development, MGNREGA Division vide Letter No. 373836 dtd.23.12.2021 and Letter No.134 dt.03.01.2022 of Director Special Projects, PR & DW, Deptt., Odisha ,Bhubaneswar Fresh expression of interest are invited from willing persons to be engaged as Ombudsman in Deogarh District for redressal of Grievances and disposal of complain relating to implementation of the MGNREG Act and MGNREGS for tenure of 2 years extendable not more than twice by one year each based on performance appraisal process or till the incumbent attains the age of 68 (sixty eight) years, whichever is earlier. There shall be no reappointment. In case there is any vacancy due to resignation, removal, death etc., the person next in the approved panel shall be offered the appointment as Ombudsman without calling for a fresh meeting of the Selection Committee.

Eligibility Criteria: The person fulfilling the following criteria may apply for selection of district ombudsman under MGNREGS in Deogarh District.

- Minimum 30 years of experience in academics (teaching) or civil service of civil society organization.
- Person with eminent standing and impeccable integrity.
- Not a member of any recognized political party or currently banned organization.
- Physically active, capable of and willing to conduct filed visits to remote rural areas in the State;
- Below 66 years of age at the time of appointment.

Appointment: -The Ombudsman in the District will be appointed by the State Govt. on the recommendation of the Selection Committee.

Remuneration: -The Ombudsman shall be allowed compensation in the form of a fee of Rs.2250/- (Two thousand two hundred fifty) per sitting with maximum upper limit of Rs.45,000/(Forty-five thousand)per month.

Removal: -On unsatisfactory performance the Ombudsman may be removed by the State Govt. on the recommendation of the Selection Committee.

Territorial Jurisdiction: - The Office of the MGNREGS Ombudsman shall be located at District Headquarters, Deogarh. The willing persons full filling the above criteria may submit their written expression in the prescribed Performa available in the following website along with copy of the required documents to the Collector-cum-DPC, MGNREGS, Zilla Parishad, Deogarh -768119 latest by 05.02.2026 through Speed Post/Registered Post only. The application received after the due date will not be considered.
