All stakeholders likely to be affected by the proposed changes are hereby invited to submit their objections or suggestions, if any, in writing, along with supporting documents, to the undersigned **within 15 days from the date of publication of this Public Notice**. Objections or suggestions received after the stipulated period shall not be entertained. In case no objection is received within the prescribed time, it shall be presumed that there is no objection from the public, and the Government may proceed further in the matter as per law.
