Sealed quotations are invited from interested reputed Travel Agencies, Tour Operators, or Private Individuals for providing 01 (one) number of AC/Non-AC Diesel/Petrol driven Vehicle (Indigo/Swift Dzire or similar) on a monthly hiring basis for official use in the Census Cell, Collectorate, Deogarh for the month from April to June 2026 .

1. Vehicle Specifications & Rates


- **Vehicle Type:** Preferably Swift Dzire, Indigo, or Xcent).
- **Model:** The vehicle must be in good condition, preferably not more than 3 years old (BS-VI compliant).
- **Monthly Hire Charges:** Maximum monthly hire charges (excluding fuel) shall be 24,000 per month.
- **Fuel Efficiency:** The vehicle must achieve a minimum fuel efficiency of 17 kms per litre.

2. Terms and Conditions

- **Maintenance:** All costs related to repair, maintenance, spare parts, and lubricants will be borne by the owner/agency.
- **Driver:** The owner must provide a dedicated driver with a valid driving license. The driver's salary and fooding will be the responsibility of the owner.
- **Documents:** The vehicle must have a valid Registration Certificate, Insurance, Fitness Certificate, Pollution Certificate, and Commercial Permit.
- **Usage:** The vehicle should report for duty for a minimum of 25-26 days per month or as per requirement.

The sealed quotation should be submitted in the District Census Cell by 9th April, 2026. Quotations received beyond the stipulated date shall not be considered.
