### Details of Auction

1. **Name of Work:** Auction of damaged/condemned building and disposal of salvage materials.
2. **Location:** Deogarh College, Deogarh. (Room No. 7 and 8) present in the rear side.
3. **Inspection of Site:** The interested bidders may inspect the building and materials during office hours from 11 AM to 2 PM.
4. **Earnest Money Deposit (EMD):** Rs 5000.00 (Rupees Five thousand only) in the form of Demand Draft/Banker's Cheque in favour of Principal, Deogarh College, Deogarh.
5. **Last Date of Submission of Bid:** 25.6.2026 up to 3 PM.
6. **Date and Time of Opening of Bids:** 27.6.2026 at 11 AM in the office of the Principal, Deogarh College, Deogarh.
7. **Base Price:** Rs. 268000.00 (Two Lakh Sixty Eight Thousand Only)

### Terms and Conditions

1. The auction shall be conducted on an "as is where is" basis.
2. The highest bid shall ordinarily be accepted, subject to approval of the competent authority. The authority reserves the right to reject any or all bids without assigning any reason.

3. The successful bidder shall deposit 25% of the bid amount immediately after acceptance of the bid and the balance amount within 07 (Seven) days.
4. The successful bidder shall dismantle and remove the materials at his/her own cost and risk within 15 days from the date of issue of the work order.
5. All labour, transportation, safety measures, statutory permissions, and liabilities shall be borne by the successful bidder.
6. No damage shall be caused to adjoining structures, electric lines, pipelines, trees, or other college properties during dismantling.
7. The bidder shall comply with all applicable labour and safety regulations.
8. EMD of unsuccessful bidders shall be refunded without interest after finalization of the auction.
9. In case of default, the EMD/security deposit shall be forfeited.
